Application Deadline: August 17, 2018

Festival Date/Time: September 1 and 2, 2018 (8am-2pm) **Rain or Shine**

(Set-up is from 6am-8am)

Fees: Reservation is for (2) days. September 1 & 2, 2018

- Community Organizations may reserve a single booth free of charge
- 10X10 Single Booth Space - \$150.00
- 10X20 Double Booth Space - \$250.00

Fees are non-refundable.

Selection Process: Vendors will be admitted based on space availability and product distinction. We make an effort to be friendly to the environment. Preference will be given to those vendors who can display a willingness to and a history of "keeping it green". The Taos Yoga Festival™ Committee reserves the right to reject any application.

Vendor Passes: Vendors will be issued 3 festival tickets for each booth rental (a \$150 value) and are encouraged to participate in the workshops, classes, and other attractions.

Space Assignments: All spaces are located on grass. Space assignments are not guaranteed. The Taos Yoga Festival™ Committee reserves the right to change space assignments as necessary.

Electricity: Access to electricity is limited. Vendors must provide their own heavy duty extension cords and adaptors. Generators may be used with special permission.

Taxes: All vendors are responsible for collecting and reporting New Mexico State and Local Sales Tax, currently 8.5%.

Vendor Responsibilities:

Set-up/Clean-up: Vendors are responsible to provide and set-up their own tents, tables and displays. Vendors must return the area to its original condition; clean and pristine. Please do not leave behind any garbage or refuse at your booth.

Weather: Taos Yoga Festival™ will be held rain or shine. Weather can be windy and vendors are encouraged to anchor and secure their booths.

Liability Insurance: Vendors are responsible to obtain, maintain, and provide for inspection, a certificate of insurance where applicable.

NO ALCOHOL: Vendors are prohibited from selling or consuming alcohol during Taos Yoga Festival™

NO CBD: Sale of CBD products is prohibited at KTAOS Solar Center.

NO ANIMALS: Animals are not allowed at KTAOS Solar Center.

The undersigned agrees that Taos Yoga Festival™, its advisors and principles, and/or KTAOS Solar Center will not be held responsible for any loss, theft, or damages that might occur. I have read and agree to abide by the Rules & Regulations governing the Taos Yoga Festival™.
