

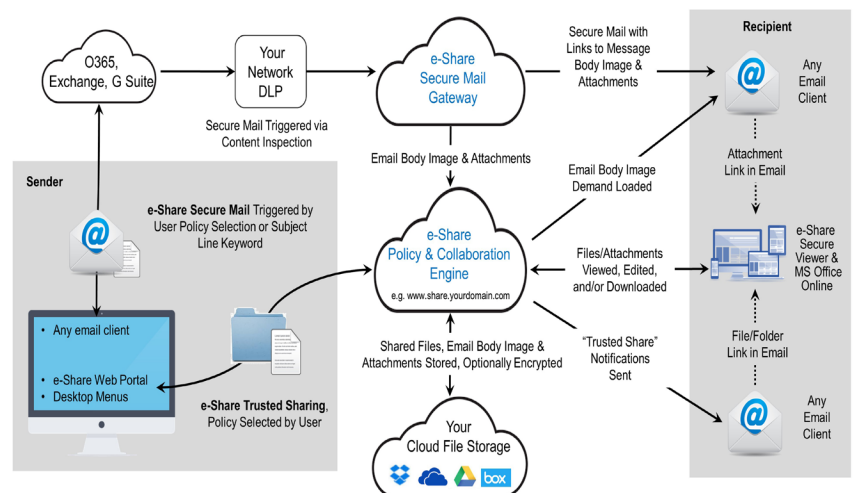

e-Share **Trusted Sharing** makes sharing sensitive information outside of your organization simple and secure. No plug-ins. And it works the way recipients want to work, with the tools they already use, providing on-demand access to the files and folders they need.

- **No Passwords to Manage** – The use of SmartURLs makes it simple for recipients to receive, view, comment, edit and even message with other document editors without the need to register for an account or remember a password.
- **On-Demand Virtual Data Rooms** – Each file and folder shared automatically creates a private virtual data room for senders and recipients, enabling them to collaborate in real-time without IT involvement.
- **Rapid adoption** – With an interface and features that mimic cloud storage providers and with nothing to install, deployment and adoption of e-Share across the enterprise requires very little end user training. Integrating e-Share with existing network DLP solutions automatically secures emails, giving organizations extended control over email attachments.

RELIABLE

e-Share **Trusted Sharing** enables customers to use their trusted domain name and branding to share with external partners, ensuring links are never blocked and the data being shared is authentic and trustworthy.

- **No Link Blocking** – Links from Google Drive, Box, OneDrive and Dropbox are often blocked by a recipient's IT team in fear of data loss, and blocked by China as part of its national censorship program, making them unreliable, but with e-Share, links are sent from your organization's sub-domain and implicitly trusted.
- **Private Branding** – e-Share allows you to present a private collaboration service to your team, clients, vendors and partners, using your logo, colors, terms of use, etc. Private branding strengthens your brand and instills confidence and trust on the part of those you are collaborating with.
- **No Software Download** – e-Share never requires recipients to download or install software, so it's far more reliable. Yet you stay in control of all the files you share.

SECURE

e-Share's Secure File Sharing Framework provides an advanced layer of information management and encryption capabilities that deliver fine-grained access, tracking, compliance and privacy controls.

- **Control & Track Every Action** – With e-Share Trusted Sharing you have access to the widest range of sharing controls such as view only, online editing, watermark and more, all tracked in compliance with today's privacy and security regulations.
- **You Hold the Key** – Unlike other cloud file storage services, e-Share's encryption system prevents e-Share and the underlying cloud file storage provider from accessing any data. And your corporate admins have absolute control, able to audit and control any access point.
- **File Level Rights Management** – **Trusted Sharing** is a browser-based collaboration system, with access expiration, view only access and online editing and co-authoring that requires no plug-ins to install or software to download.
