ROE v. WADE IS DEAD, BUT FLORIDA'S "ROE" IS STILL ALIVE!

You may think that everything is fine now that Roe v. Wade has been overturned. You may even be under the impression that abortion is now illegal in Florida.

NOTHING COULD BE FURTHER FROM THE TRUTH!

Abortion is still legal and thriving in Florida. In 2022 alone, we murdered over 82,000 human beings by abortion, under the new "15-week ban"! The new six-week abortion ban that just passed in 2023 is not yet effective as of May 2023. But last year, more than HALF of the abortions in Florida were committed at or prior to 6 weeks.

WHAT IS FLORIDA'S "ROE"?

In 1989, in a case called "In Re T.W.," the Florida Supreme Court ruled that the Florida Constitution's Privacy Act allowed a woman to get an abortion. T.W. has thus become our "Roe," being used as an excuse to keep abortion legal in Florida for the past three decades.

Florida's 15-week ban was intended specifically to challenge T.W. in the same way the Dobbs case was intended to challenge Roe! Planned Parenthood immediately filed suit against the 15-week ban and that lawsuit is currently still pending before the Florida Supreme Court. Planned Parenthood of SW and Central Florida v. State of Florida is now Florida's "Dobbs," fighting against "T.W", which is Florida's "Roe."

A judge determined that Florida could still enforce the 15-week ban while the case is pending before the Supreme Court, so until Florida's "Roe" is decided, abortion will be "legal" up to 15-weeks!

BUT THAT ISN'T THE ONLY PROBLEM – FEDERAL LAWS MAY BE PASSED TO ALLOW ABORTION!

As you have no doubt heard, the current Biden/Harris administration wants to enshrine a right to abortion into Federal law. If they do that, many people think that each of the states would have to then allow abortion.

NO LAW CAN ALLOW MURDER

But no law can allow murder. No federal law, no constitutional amendment, no privacy act, no court ruling, no regulation. No governor, no president, nor even a king can allow murder. Because human beings are made in the image of God, God's law trump's man's law. Further, every human being is protected by US law under the 5th and 14th Amendments to the US Constitution. Therefore, NO LAW allowing murder is valid.

IGNORE "T.W." -- JUST LIKE WE SHOULD HAVE IGNORED "ROE!"

We should have ignored and defied Roe v. Wade from the moment the ruling was handed down. Likewise, we must ignore "T.W." Like Roe, TW is an iniquitous decree. An unconstitutional and illegal ruling. Florida has no requirement to obey it!

THE US CONSTITUTION FORBIDS ABORTION

The 5th Amendment to the US Constitution states: "No person shall be . . . deprived of life, liberty, or property, without due process of law."

The 14th Amendment to the US Constitution states: “No State shall . . . deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.”

THE FLORIDA CONSTITUTION FORBIDS ABORTION

ALL PERSONS ARE EQUAL UNDER FLORIDA LAW

Article I, Section 2 of the Florida Constitution says: Basic rights.—All natural persons, female and male alike, are equal before the law and have inalienable rights, among which are the right to enjoy and defend life and liberty, to pursue happiness, to be rewarded for industry, and to acquire, possess and protect property. No person shall be deprived of any right because of race, religion, national origin, or physical disability.

Article I, Section 9 of the Florida Constitution says: Due process.—No person shall be deprived of life, liberty or property without due process of law, or be twice put in jeopardy for the same offense, or be compelled in any criminal matter to be a witness against oneself.

BUT WHO IS A PERSON UNDER FLORIDA LAW?

1.01(3), Florida Statutes, describes “person” as follows: “The word “person” includes **individuals, children, firms, associations, joint adventures, partnerships, estates, trusts, business trusts, syndicates, fiduciaries, corporations, and all other groups or combinations.**

THEREFORE, ALL LIVING HUMAN BEINGS ARE PROTECTED UNDER FLORIDA LAW!

The 15-week ban is ILLEGAL! The 6-week ban is ILLEGAL! In Re T.W. ruling is ILLEGAL! THEY MUST BE IGNORED. THEY MUST BE DEFIED!

GOD’S WORD FORBIDS ABORTION
