2. **DJ Requirements.** DJ requires the following space and electrical requirements inorder to provide DJ & Entertainment Services. **Space Requirements:** Client is responsible for providing DJ-B Entertainment with reasonable working area, including a space no smaller than **10 X 15** ft.

**Electrical Requirements:** Client is responsible for providing DJ-B Entertainment a live power source within 100 ft. of the DJ booth setup.

**Setup Requirements:** Client is responsible for providing DJ-B Entertainment access to the venue no later than 24 hours before the event for the purpose of equipment setup and sound check.

#### 3. Cancellation.

<u>By Client.</u> Client may cancel this Agreement at any time prior to the event. Upon cancellation, Client will be entitled to a refund of any monies paid, except for the non-refundable deposit. The is Contract may only be cancelled by written notice by email or certified mail.

<u>By DJ</u>. DJ may cancel this Agreement at any time. If DJ cancels, it must provide a suitable, replacement DJ, subject to Client's approval, which shall be obtained in writing. In the alternative, DJ shall refund all monies previously paid by Client, including the non-refundable deposit.

- 4. **Dispute Resolution and Legal Fees.** In the event of a dispute arising out of this Contract that cannot be resolved by mutual agreement, the Parties agree to engage in mediation. If the matter cannot be resolved through mediation, and legal action ensues, the successful party will be entitled to its legal fees, including, but not limited to its attorneys' fees.
- 5. **Severability.** In the event any provision of this Agreement is deemed invalid or unenforceable, in whole or in part, that part shall be severed from the remainder of the Agreement and all other provisions should continue in full force and effect as valid and enforceable.
- Legal and Binding Agreement. This Agreement is legal and binding between the
  Parties as stated above. This Agreement may be entered into and is legal and binding
  in Canada. The Parties each represent that they have the authority to enter into this
  Agreement.
- 7. **Governing Law and Jurisdiction.** This DJ Services Contract shall be governed by the laws of Canada. Any disputes not resolved directly between the parties to this contract shall be resolved in a civil court located in Alberta, Canada

8. **Entire Agreement.** The Parties acknowledge and agree that this Agreement represents the entire agreement between the Parties. In the event that the Parties desire to change, add, or otherwise modify any terms, they shall do so in writing to be signed by both parties.

\*DJ recognizes that the event listed in this contract is a rain or shine event and agrees that weather shall not prevent the performance of the services listed in this contract. However, lightning is considered an exception due to the metal framing necessary for light and speaker mounts, and as a result the DJ shall be able to cease operations should a lightning threat be present.

## **Additional Agreements:**

Client shall be responsible for ensuring that all event attendees treat the DJ and any
equipment on-site with respect. In the event that an attendee acts in a manner which the D
judges to be dangerous, threatening, or inappropriate, the DJ agrees to provide the Client with one opportunity to correct the behavior. If the problem persists, the DJ may, without warning, cease providing DJ services and vacate the event. If this occurs, the Client will be responsible for full payment of the fees listed in this contract without exception.
Client agrees to provide DJ & DJ Assistant with meal and beverages during the course of the event.
Client gives permission to DJ-B Entertainment to use photos & videos of the event for the purpose of advertising only, on DJ-B Entertainment Social Media pages (i.e., Facebook
Twitter, Instagram etc.) and on DJ-B Entertainment website.

## **Acceptance:**
