COVID19 SAFETY PRACTICES POLICIES & PROCEDURES

In addition to Alabama's *Safer at Home Order* and the *Guidelines for Safeguarding All Businesses*, the following practices shall be adhered to by Goudy Entertainment Center until further notice.

TO OUR GUESTS:

When appropriate, we will require reservations-only and call-ahead seating.

- Signage will be provided when the venue has reached capacity.
- Additional guests will be required to remain in their vehicles or socially distanced outside until venue capacity has decreased.

Masks must be worn at all times, with a very narrow exception.

- Masks may be removed ONLY when eating or drinking alone or while with a member of your designated companion/group.
- Groups will be limited to 8 or fewer persons.
- When worn, masks must cover the nose and mouth at a minimum.
- Masks are NOT a replacement for social distancing. You are expected to both wear a mask AND practice social distancing.
- Masks will be available for guests who arrive without their own.

<u>Depending upon occupancy numbers and company discretion, temperature checks</u> may be required before entry onto the premises.

- Readings of 100° or higher will NOT be allowed inside of the venue.
- Acceptable readings will be provided a sticker indicating successful safety check.
- Guests may be screened in accordance with CDC guidelines.

Adhere to social distancing guidelines in all areas and at all times within the venue.

- Recommended social distancing is six (6) feet apart.
- Do not move or rearrange bar seating or tables inside of the venue. Furniture
 has been pre-placed in compliance with state and local health department
 recommendations and guidelines.
- Follow all distancing illustrations, reminders and signage provided.

Bar counters, stools and tables must be sanitized between use.

- Please be patient as Team Members wipe these areas to protect the safety and health of the next guest.
- If a guest leaves and the area has not been wiped, please do not use that area until a Team Member has properly sanitized and given you permission to assume the space.

Hand sanitizers, disinfecting wipes and such other cleaning materials are provided for your use, as often as necessary.

A designated member of the Goudy team will monitor guests and Team Members inside and outside of the venue regularly during opening hours to observe and ensure that all persons are practicing the guidelines listed herein.

 Guests who refuse to abide by these guidelines endanger the health and safety of everyone and will be asked to leave the venue.

No handshakes allowed.

 At the present time, we must prohibit handshakes and other person-toperson contact (hugs, hi-fives, fist bumps, etc.).

NOTE: Goudy Entertainment Center reserves the right to close the venue at any time for the safety of all patrons, requiring everyone to leave.

THE GOUDY TEAM:

Requirements have been established to ensure that safety, cleanliness, and caution extend to the parts of the venue Guests do not see.

- Goudy Entertainment Center is following guidance from the CDC, Alabama State Department of Health and the Jefferson County Health Department on how and when to exclude Team Members who are diagnosed, sick or exposed to COVID19.
- Anyone who displays symptoms is required to stay home and not return based on CDC and state guidance.
- Upon reporting to work, Team Members are prompted to review a list of symptoms, including those directly associated with COVID19.
- Thermometers are used to check Team Member temperatures upon arrival. Temperatures of 100° or higher will not be allowed inside of the facility, but sent home in accordance with CDC and health department guidelines.
- Team Members must wear approved face coverings, which follow the CDC's recommendation to help prevent the spread of COVID19. Team Members are not required to wear medical-grade masks or face coverings, as these should be reserved for healthcare workers.
- Team Members are required to wash uniforms, reusable masks and shirts after each shift and prior to reuse.

All of our hand washing procedures are developed in strict adherence to CDC and FDA guidelines. The CDC and Surgeon General have advised hand washing with soap and water as one of the most effective ways to reduce risks of transmitting an infection. Therefore:

- Team Members have been instructed to wash their hands at a minimum of every 30 minutes and to sanitize hands even more regularly.
- Team Members are required to use gloves while preparing or serving drinks or food.
- Team Members are also required to wash hands and/or use a fresh pair of gloves after handling cash transactions.

Our team will institute social distancing practices and limit any physical contact with Guests and other Team Members.

• We have provided visual diagrams where possible.

- Tables and chairs have been arranged to ensure at least six feet of distance between them.
- Some tables and chairs have been eliminated to ensure a safe distance of six feet of distance between them.
- For safety reasons, hospitality amenities (straws, napkins, etc.) will not be located on tables until further notice. Team Members will provide them to guests directly.

Goudy Entertainment Center uses regularly three (3) different cleaners located on the EPA list of antimicrobial products purported as acceptable to use against or kill COVID-19. Team Members will use these products to clean and disinfect counters, chairs and tables after each use, as well as high-touch equipment and surfaces in throughout the venue, to include:

- Kitchen, bathrooms, and door handles, approximately every sixty (60) minutes;
- Bar counters and stools after each use;
- Dining room tables and chairs after each use; and
- Tablets, credit card readers, point of sale systems, cash and delivery bins, and shelving after each use.

As Guests arrive at the restaurant and enter the venue, safety, health and wellbeing of everyone is our priority. To provide a safe and healthy experience:

- Hand sanitizer stations will be available throughout the venue for customer use.
- Guests will have the ability to swipe their own credit card or provide credit card PIN entry or sign for receipts.
- Team Members will use a plastic bin/container to collect cash and return change.
