

SPLASH INTO SUMMER Zazza Radio Contest Rules

Effective as of Monday, June 15, 2026

The “SPLASH INTO SUMMER” contest (“Contest”) from Zazza Nation, LLC (“Sponsor”) is subject to the general contest rules as posted at www.ZazzaNation.com/contest-rules (“General Rules”). The “SPLASH INTO SUMMER” Pre-Promote phase will begin Monday, June 15, 2026 and run through Sunday, June 21, 2026. The contest will run for the period of time beginning on Monday, June 22, 2026 through Friday, July 3, 2026, (the “Contest Period”), with the Grand Prize winner being announced on-air on Monday, July 6, 2026. Defined terms not defined herein shall have the meanings ascribed to them in the General Rules.

Prizes:

Qualifying Prizes: Each weekday (Monday-Friday) during the Contest Period, a pack of four (4) 1-Day tickets (each a “Family 4-Pack” or “Qualifying Prize”) may be awarded to an eligible Contestant for potential admission to either (not both) Disney’s Blizzard Beach or Disney’s Typhoon Lagoon Water Park (each individually a “Water Park” and collectively, the “Water Parks”) with an expiration date of July 31, 2027. There are up to ten (10) Qualifying Prizes available during the Contest Period.

Grand Prize: one set of four (4) single-use Disney’s H2O Glow After Hours event tickets for Disney’s Typhoon Lagoon Water Park for use ***exclusively on Saturday, August 29, 2026***. Disney’s H2O Glow After Hours is a separately priced, hard-ticket event held from 8:00 PM to 11:00 PM. The Grand Prize ticket winner may enter Disney’s Typhoon Lagoon Water Park as early as 6:00 PM.

How to Win:

Listen, for your chance to win, weekdays (Monday-Friday) during the Contest Period to the Zazza Show, from 6am-10am Eastern Time. When you hear the “Cue to Call”, the 10th caller at 866-208-6699 or by using the “Call Now” feature inside the Zazza Nation App, will win a Qualifying Prize (each winner a “Qualifying Winner”). In the event the 10th caller is ineligible, Sponsor may award the applicable Qualifying prize to the next eligible caller.

The Grand Prize winner will be randomly selected from the Qualifying Winners and will be announced on-air on Friday, July 3, 2026. The Grand Prize winner *must* complete, sign, and submit an IRS Form W-9 and submit a valid copy (front and back) of their state-issued ID to Sponsor (together with the IRS Form W-9, the “Required Information”) in order for the Grand Prize to be processed and awarded. In the event the Grand Prize winner fails to submit the Required Information to

Sponsor by July 20, 2026 at 5:00 PM Orlando, Florida time, the Grand Prize winner shall be deemed to have refused the Grand Prize and Sponsor may randomly select a new Grand Prize winner from the remaining Qualifying Winners (a "Runner-Up Winner"). Such Runner-Up Winner shall have until August 3, 2026 at 5:00 PM Orlando, Florida time to submit their Required Information to Sponsor in order for the Grand Prize processed and awarded. Notwithstanding anything herein to the contrary, such deadlines are subject to change upon requirements by Disney, in its sole discretion. In the event Disney, in its sole discretion, requires different timelines for processing the prizes under this Contest, such requirements shall govern, and Sponsor shall modify these rules as soon as reasonably practicable to reflect such requirements.

Each winner shall be subject to applicable IRS rules and taxes based on the current IRS Code, including without limitation, the rules and taxes for receiving prizes totaling six hundred dollars (\$600) (the "Threshold") or more in any given year. The approximate retail value of each Qualifying Prize is \$315.24 (three hundred fifteen and 24/100 dollars), and the Grand Prize approximate value is \$279.16 (three hundred seventy-nine and 16/100 dollars). The total approximate value the Grand Prize winner is \$694.40 (six hundred ninety-four and 40/100 dollars). In the event actual value differs from the included approximate values, the difference in the amount(s) shall not be awarded. Each winner must be at least eighteen (18) years of age to enter and win. Travelers under the age of eighteen (18) must be accompanied by a parent/legal guardian who must be at least eighteen (18) years of age.

Water Park tickets are nontransferable and are valid only during specific event dates and hours. Prize winners must guard Water Park tickets against loss, theft, or damage.

Certain Water Parks, resorts, restaurants, and other offerings may be modified or unavailable, limited in capacity, and subject to limited availability or closure. Water Park admission and offerings are not guaranteed. Water Park attractions and entertainment are subject to change in availability due to rehabilitation, seasonal, capacity, and weather closures. In the event any element of the Grand

Prize tickets proves to be unavailable or is otherwise unfulfilled, Disney shall have the right to withdraw the Grand Prize tickets or any parts thereof in its sole discretion.

To visit a Water Park, valid admission is required for the same Water Park on the same date for each prize winner aged 3 and above.

In the event that any winner (including without limitation such winner's guests, family, or otherwise member of winner's traveling party) engages in behavior that, as determined by Disney in its sole discretion, is obnoxious or threatening; illegal; is intended to annoy, abuse, threaten, or harass any other person; or is contrary to Disney's health and safety protocols, rules, or policies in effect at the time the Water Park ticket is redeemed, Disney reserves the right to terminate the Water Park tickets or other applicable experience early, in whole or in part, and send the winner(s) home with no further compensations. The winners expressly acknowledge and agree to be solely responsible for any actions, claims, or liabilities.

Sponsor shall have the right, but not the obligation, to make any deductions and withholdings that Sponsor deems necessary or desirable under applicable federal, state, and local tax laws, rules, regulations, codes, or ordinances.
