- IV. To ensure selection of outstanding professionals, the President of the Taiwan Corporate Sustainability Academy serves as the Awards Convener (and Chairman), and selects exemplary judges from the community to serve on "GCSA Professional Selection Committee", (hereafter, the Committee).
- V. The Committee will undertake both preliminary and final rounds of review for submission for selection by the Taiwan Corporate Sustainability Academy, and those selected are the winners of the "GCSA Professional".
- VI. The Award trophy (plaque) will be issued to winners at the annual Global Corporate Sustainability Awards Ceremony.
- VII. Upon approval of these Awards Guidelines by the Taiwan Corporate Sustainability Academy, and ratification by the Convener, these Guidelines shall take effect from the date of promulgation, and the same applies as to any amendments thereafter.
