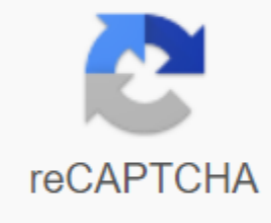

Document formatting requirements - Use 8.5 x 11 inches of white paper weighing 20 inches. The fields should be cleared of all markings and at least 1 inch. The font size should not be less than 10 points. Use black ink for best results. Bilateral printing is permissible until the text bleeds. If a page has a print on both sides, it will be counted as two pages. Indecipherable and/or modified documents will be returned as unscripted. All documents must be original and recognized. Confessions must include: county, state, date, person or corporate officials appear, notary signature, notary seal, and notary expiration date. The confirmation date may not precede the execution date. A foreign language document must include an English translation that has been sworn in or confirmed by an interpreter. The translation will be recorded together with the original. The names in the document should be consistent. Underneath them, the original signatures are dark blue or black ink, which must have appropriate names. Land-related documents must indicate the municipality, county and state where the property is located. A legal description must also be provided. It should be on the front page. Documents, mortgages, and mortgage concessions must have a grant or mortgage address placed on it (Certificate of Residence). Address must be certified by the signature and the date. If a person is human The document prepared is the same person who submitted the document, name and address must be entered twice. Don't use the same thing as above or combine entries for the Return in and Prepared section. Previous book and page numbers should appear in all documents referred to the original record. The relevant tax card numbers should be displayed in all land-related documents. All documents require a single site ID for the recording to take place. This number should be placed in the top left corner of the first page. The number is usually issued by the appraisal office. Multiple entries that make up a single transaction must be clearly measured in the proper manner in which they are placed on the record. The documents are re-written and new evidence and explanations of why they are being registered. TRANSFER TAX AND STATEMENT OF VALUE 1% state and 1% local transfer tax must be paid at the sale price or fair market value of all non-missing property documents at the time of registration. Documents submitted with non-native property in more than one municipality and/or school district should clearly know the percentages (generally) regarding the division of local transfer taxes. All documents exempt from the transfer tax must be accompanied by a declaration of value. In the case of transfer between close family members, a exemption clause may be placed in the case. A statement of value must be submitted by a duplicate. SOV is considered additional pages when charging fees.
