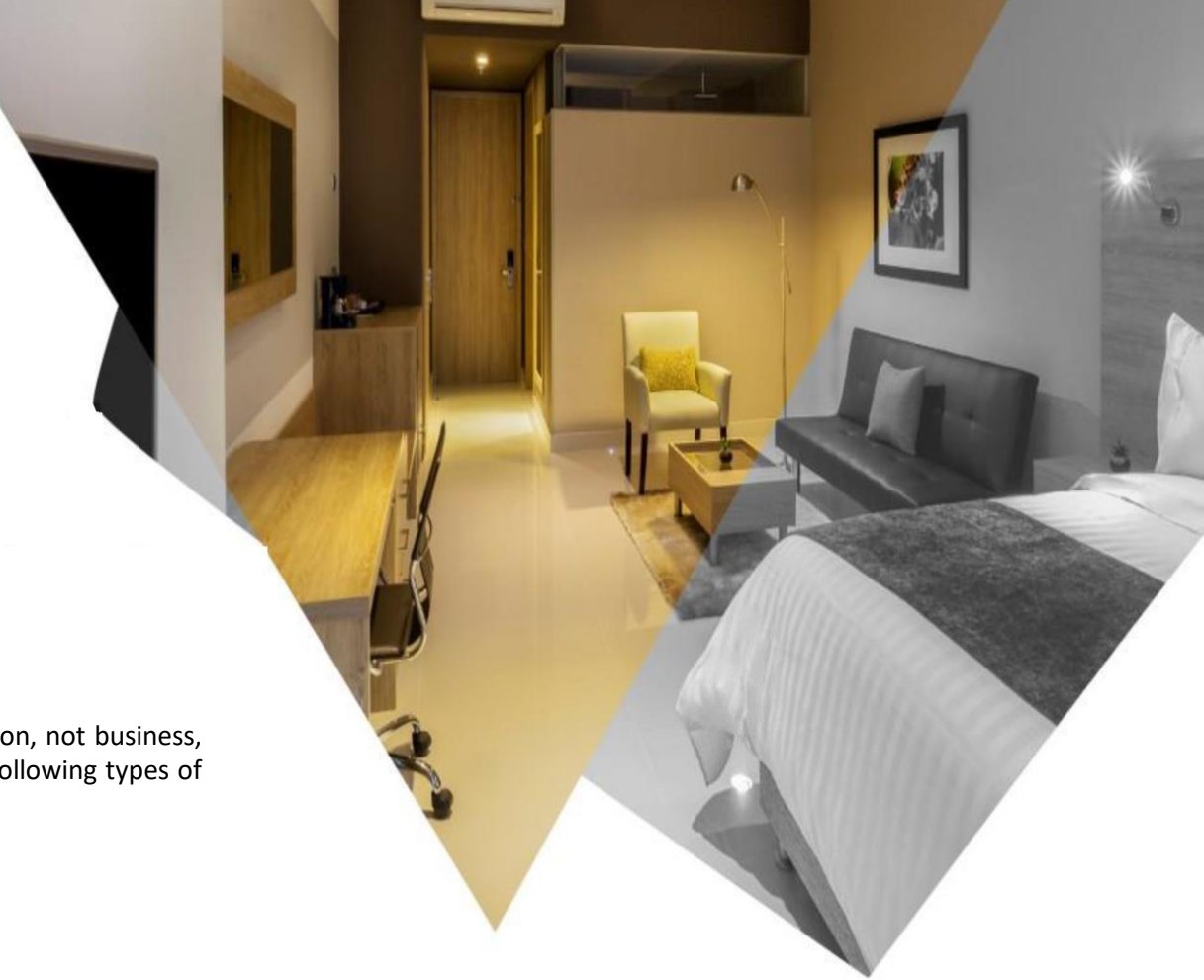

- TP-11 Visa

## PAYMENT METHDS

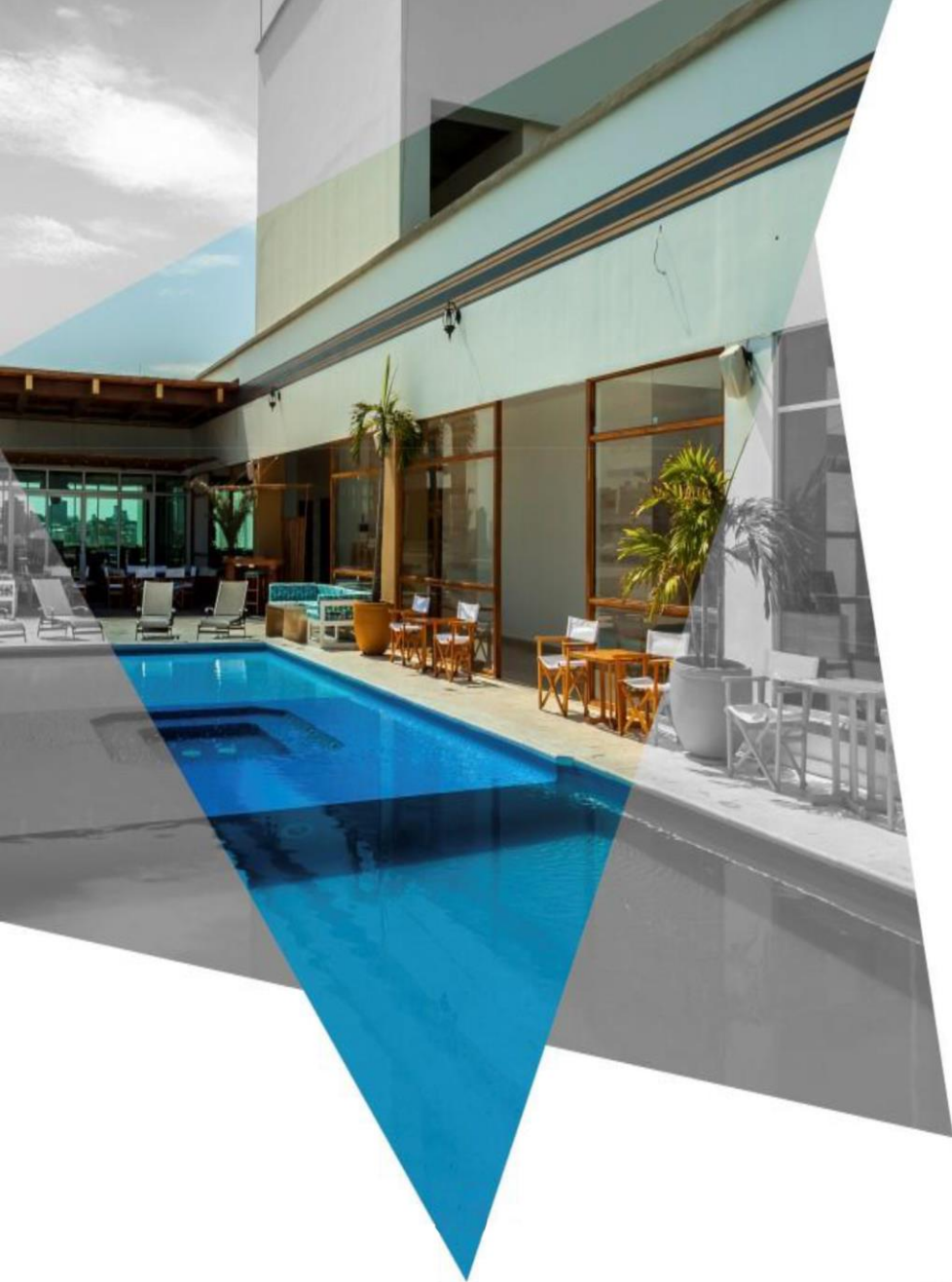

## **CANCELLATIONS (DOES NOT APPLY IN HIGH SEASON)**

The cancellation policy of the hotel is until 9:00 a.m. (local time) on the day of arrival of the reservation, any change, modification or cancellation must be made before this time.

If the reservation is canceled please request a code otherwise the reservation is considered valid.

The previous cancellation policy only applies for individual reservations. The restrictions for cancellations of reservations and number of group nights vary according to the number of rooms booked.

For groups of more than thirty (30) rooms, between one (1) night and three (3) nights booked, the hotel will accept cancellations received up to sixty (60) days before arrival without any charge to the company. Cancellations received more than thirty (30) days and less than sixty (60) days from the date of arrival, will be charged for 100% of the value of the first night plus the corresponding taxes and cancellations received with less than thirty (30) days of the arrival date, will be charged for the total value of the three nights of lodging plus the corresponding taxes of the rooms not used.

## **WARRANTY (DOES NOT APPLY IN HIGH SEASON)**

The reservation is guaranteed by letter directly from the company (only if the company has current credit and active with us), or with a credit card number and the expiration date.

Reservation only confirmed is considered WITHOUT WARRANTY, for this reason the hotel reserves the right to keep it active depending on the occupation.

The letter of the company and / or the credit card are guarantee of the payment of the NO SHOW in case of non-fulfillment of the reservation will be charged the total value of the night.
