

Our clients are people with illness, disabilities or loss of employment, which limit their earnings.


Our clients are people who need public entitlements like SSD/SSI, TANF, Medicaid and SNAP food benefits.

Legal Services of Northwest Jersey offers legal advice and services such as document preparation, as well as extended representation in matters in court and before administrative agencies.


We provide these legal services with qualified and trained staff attorneys and pro bono counsel.





2021 – Debt collection cases resume in the Courts

The effects of the COVID-19 pandemic continued to impact our community. The closing of courts, eviction moratorium and moratorium on suspension of Medicaid benefits had limited applicants' access of services, and reduced case numbers in areas involving litigation.

- ★ LSNWJ continued with our expansion of services to meet the current needs. The Public Entitlements Team continued its Unemployment Benefits/Pandemic Unemployment Advice Panel, which had been initiated the preceding year.
- ★ The Courts modified landlord tenant rules with new case management and conferencing initiatives. The Housing Team continued community education, legal advice and representation in an effort to connect tenants with resources and divert evictions.
- ★ LSNWJ's Board of Trustees formed a Pro Bono Team with staff to train pro bono counsel, in anticipation of an ultimate tsunami of eviction cases.
- ★ Planning an extension of services in the expungement of criminal records, staff went into the community with legal information for the public, and legal education for attorneys and volunteers.
- ★ LSNWJ Outreach continued online, outdoors and on the road. A staff liaison joined Morris County's Hope Hub, in a new project to go out to find the need, and connect people to services.
- ★ The organization grew, with six new hires to meet the anticipated growth of demand for legal services, as pent up demand for suit by creditors, landlords and agencies would create case and time pressures for clients and advocates.
- ★ LSNWJ strengthened its leadership capacity and succession planning with the addition of a Chief Operating Officer.

Expenses

In 2021, 90% of LSNWJ resources supported program work.

The expense for Program Management, Administration, and Fundraising increased from

10% to 15% in 2022, still a spare fraction of the overall budget.

Bono.



2022 -Eviction matters return to the court's docket


While teams continued extending more advice services on credit repair, small claims, and unemployment benefits, LSNWJ recognized the urgent priority of cases involving

- ★ Tenancy eviction defense, especially in subsidized housing;
- ★ Illegal/Self Help evictions, including utility shut offs by the landlord;
- ★ Notice of Termination of housing subsidy;
- ★ Ejectment defense.
- ★ The Housing Team commenced rotation of on call attorney coverage for response to housing emergency cases.
- ★ Staff and pro bono all contributed in LSNWJ eviction diversion clinics. These were held day or evening at local library branches and virtually through Zoom.
- ★ Morris County Superior Court held a weeklong "blitz" of trials to clear its eviction case backlog. The Court scheduled 225 eviction cases to be heard over one week in April. It took a program-wide effort as staff from multiple county offices assisted local attorneys to meet the needs of tenants in court.
- ★ The year's end would conclude the LSNWJ contract for representation in mental health involuntary commitments to a psychiatric hospital. In 2023, these clients would have Public Defender representation. The conclusion of commitments representation frees staff to respond to the pressure of increased need in anti-eviction work and consumer debt defense.
- ★ Staff returned to work in-office on hybrid schedules.
- ★ New technology needs resulted in a roll-out to all staff of Zoom phones through computers, maintaining efficiency from remote locations. LSNWJ's IT is administered by LSNJ, the statewide coordinator of legal services in New Jersey.
- ★ LSNWJ hosted six CLE webinars over three months, on bankruptcy, tenancy law, and expungements, for staff and pro bono.
- ★ New hires: 6 attorneys, 2 intake specialists, 1 Paralegal, 1 Social Worker, 1 Executive Admin. Assistant.


