Thank you for your interest in North Chicago Community Days. Please read through this document carefully which outlines pertinent information for exhibitor booth participants.

Booth Information:

Applications are processed on a first come, first served basis. Incomplete applications will not be accepted. Do not send in an application without payment and insurance. Applications submitted without payment and insurance will be discarded.

Community Days is a multi-day event. Vendors are expected to occupy their booth on Saturday and Sunday. *No refunds will be given for vendor cancellations or no-shows.*

To receive a special **Early Bird Rate**, **applications are due by June 1, 2019**. Any application submitted after June 1, 2019 is subject to the Regular Vendor Tent Rates.

Community Days will not give any vendor an “Exclusive” for their merchandise and/or services. Due to the limited space available for the event, we reserve the right to limit the number of vendors with the same or similar merchandise.

All vendors must list goods and services provided at their tent. Each tent will be inspected and only approved items may be sold. The city reserves the right to shut down any food vendor that does not comply. No refunds of any type will be issued to a vendor who has been shut down.

Security will be provided on the event grounds. However, vendors should not leave merchandise or personal items in plain sight. The City of North Chicago, Foss Park District or NCCUSD 187 will not be responsible for lost or stolen items.

Vendors are responsible for cleanup around your booth area.

Please indicate any booth requests on your application. *Please note: booth location requests are accepted, but not guaranteed.*

- **Temporary Food Service Sanitation Certificate** on or before July 7, 2019 from the Lake County Health Department. *Failure to comply by the deadline will result in the forfeiture of the vendor tent. - **Certificate of Liability Insurance** is required with application, listing additional insured as: City of North Chicago, Foss Park District and NCCUSD 187.
