Jeremy Tiffany expressed concern that a 15,000-chicken barn is planned for one side of his home in Pine Township and a second one on the other side of his house in Cato Township. He is concerned that this operation may be commercial rather than the agricultural use that the property is zoned for. He is also concerned about potential drainage issues into his yard.

A public hearing was held at 5:00 PM today to consider a request by Joshua Singleton for a special land use permit for the operation of a 20-acre gravel pit near the corner of Stanton Road and M-91. The PC voted to send the request, with specific amendments and stipulations, to the Board for approval.

Krause moved, supported by VanGessel, to approve the planning commission recommendation to grant a special land use permit to Joshua Singleton for the operation of a gravel pit on approximately 20 acres of property near the intersection of M-91 and Stanton Road, amended from the initial request to include being 300' from river edge, dust control, crushed asphalt drive from road to the gravel pit, pine trees or berm, driveway permits with culverts, and safety signage on Stanton Road.
