Amendment 4 was defeated in the 2024 election. And we praise God it failed! But A4 failed *only* because Florida requires a 60% majority for a constitutional amendment to pass. Amendment 4 failed with a 57.17% majority. Only 42.83% of voters voted NO!

Why did over six *million* people vote “YES” on Amendment 4 in a predominantly conservative, pro-life state?

Part of this was because of intentional deception on the part of the petition authors and the paid signature collectors. The language was intentionally vague, and there were hundreds of reports of petition gatherers blatantly lying about the Amendment.

But the main reason so many voted YES on Amendment 4 was that **we have forsaken God**. People love their sinful lifestyles so much that they are willing to sacrifice their unborn children for their lifestyle of ease and pleasure. Although many Florida churches did preach against Amendment 4, the Church in general has failed miserably for decades to communicate that abortion is a sin. As a result, millions of churchgoing Christians have gotten the idea that abortion is not such a bad thing, and

in that some cases may even be advisable.

THE SIX-WEEK BAN IS

NOT GOOD ENOUGH

Florida’s pro-life industry is now resting on its laurels, happy that we dodged the speeding bullet of Amendment 4. But make no mistake. The six-week ban has resulted in fewer *reported* abortions, but it does not protect children!

- It declares one can kill any human being in the first month of his or her life.
- It allows the murder of any baby under 15 weeks whose father is incestuous, a rapist, or a sex trafficker.
- It allows the murder of any child under 24 weeks who has been diagnosed with a terminal illness.
- It sacrifices every baby at any point whose mother is in severe medical distress. The six-week ban actually **REPEALED** the statute that required a physician to try to save a viable baby in

the event of emergency delivery.

- It commits \$25 million per year in taxpayer money toward pregnancy centers that are forbidden to even *mention* God.
- It commits \$5 million per year in taxpayer money toward "family planning," which includes every kind of birth control, including abortifacient hormonal contraceptives and IUDs. It also pays for “sex education.”

Most importantly, Florida (like every other state) refuses to prosecute any woman who kills her own child in violation of the law. This means that regardless of the six-week ban, any woman can kill her child with complete immunity, at any time up to birth.

Florida killed at least 64,000 babies in 2024, even with the six-week ban in place since May 1. We are unable to even count the thousands of babies killed by illegal mail-order pills ordered like candy online. Clearly, the six-week ban is *not* good enough.
