

**INDIANA: Protection at Conception Act - HB1430** Repeals the statutes authorizing and regulating abortion. Finds that human physical life begins when a human ovum is fertilized by a human sperm. Asserts a state interest in protecting human physical life from the moment that life begins. Court decisions to enjoin the law are void. Federal officials attempting to enforce contrary court orders against Indiana officials shall be subject to arrest.

**IDAHO: Abortion Human Rights Act** The attorney general shall monitor this state's enforcement of Chapter 40, Title 18, Idaho Code, in relation to abortion. Any federal statute, regulation, executive order, or court decision which purports to supersede, stay, or overrule this act is in violation of the constitution of the state of Idaho and the constitution of the United States and is therefore void. The state of Idaho and its political subdivision, and agents thereof, may not enter an appearance in any federal suit challenging this act.

**WASHINGTON: Abolition of Abortion in Washington - HB2154** A living human child, from the moment of fertilization, is entitled to the same rights, powers, privileges, justice, and protections as any other human person; treats as void and of no effect any and all federal acts that would deprive an unborn child of the right to life or prohibit the protection of such right. Any act of the US government that denies or prohibits protection of a human person's inalienable right to life is null, void, and unenforceable. A federal officer or agent who arrests any Washington government official for compliance with this chapter is subject to arrest by Washington law enforcement.

**ALASKA: Alaska Life at Conception Act - HB 178** Makes all human beings equal under the law, outlaws all abortion, provides for no exceptions, does not recognize federal jurisdiction in state's authority to ban abortion.

### **ABORTION IS CHILD SACRIFICE – THE MURDER OF AN IMAGE-BEARER OF GOD**

**Ex 20:13** You shall not murder.

**Gen 9:6** Whoever sheds the blood of man, by man shall his blood be shed, for God made man in His own image.

**Job 10:11** You clothed me with skin and flesh, and knit me together with bones and sinews.

**Psa 127:3** Behold, children are a heritage from the LORD, the fruit of the womb a reward.

**Ecc 11:5** As you do not know the way the spirit comes to the bones in the womb of a woman with child, so you do not know the work of God who makes everything.

**Deut 30:19** I call heaven and earth to witness against you today, that I have set before you life and death, blessing and curse. Therefore choose life, that you and your offspring may live.

**Jer 1:5** Before I formed you in the womb I knew you.

**Num 35:33** You shall not pollute the land in which you live, for blood pollutes the land, and

### **EXAMPLES OF "PRO-LIFE" REGULATION FAILURE**

- Public funding can be used to pay for the murder of preborn babies conceived in rape or incest, or whose continued nurturing in the womb endangers the life of their mother.

- A minor child can murder her preborn baby by merely notifying her parent(s), or even without their knowledge by obtaining a judicial waiver. Abortionists advise children how to get that waiver!

- Worse yet, Florida Right to Life helped codify the above "right" directly into Florida's Constitution!

- Any woman may murder her child for any reason up to 24 weeks, after merely having an ultrasound -- which she does not even have to view -- and which can easily be manipulated by the killer to portray a false image of the growing child.

### **TO REGULATE MURDER IS TO KEEP MURDER LEGAL**

Any pro-life regulation that ends with "*and then you can kill the baby*," is unjust and evil! Pro-life laws do NOT "chip away" at abortion, but serve to legitimize abortion as if it were health care. They pay reverence to and legitimize evil court

rulings. They do virtually nothing to even curb abortion. Abortion is the only act of murder that lawmakers seek to regulate rather than to outlaw. **KILLING ANOTHER HUMAN BEING CANNOT BE MADE A "RIGHT."** All "pro-life" incremental regulations specifically *permit* the murder of some babies under some circumstances. One cannot fight evil with evil.

"**HEARTBEAT**" bills sacrifice every baby whose heart has not yet begun to beat or whose already-beating heart is not yet heard. The paid killer is trusted to "look for" the heartbeat and can miss it on purpose!

"**WAITING PERIODS**" simply give a mother more time to justify and plan her murder.

"**PAIN-CAPABLE/VIABILITY**" bills sacrifice babies under 20/24 weeks (94% of FL abortions are in the first 12 weeks!).

"**DISMEMBERMENT**" bills merely require that the baby is murdered PRIOR to being ripped to bloody shreds.

"**ULTRASOUND**" laws call for the least-accurate ultrasound, but all can be easily manipulated for false results.

"**PARENTAL CONSENT**" laws sacrifice babies whose mom gets a waiver, or whose grandparents want them dead.

### **THE ONLY SOLUTION TO ABORTION IS THE GOSPEL - BUT GOD DEMANDS THAT CIVIL AUTHORITIES PROTECT ALL FROM MURDER. FLORIDA ALREADY DEFIES FEDERAL LAW & THE SUPREME COURT FOR MARIJUANA. FLORIDA HAS THE AUTHORITY TO DEFY ROE v. WADE!**

### **EXAMPLES OF RIGHTEOUS ABOLITIONIST BILLS**

**OKLAHOMA: Abolition of Abortion in Oklahoma Act - SB13** The first abolitionist bill in history to be heard in Committee! A living human child, from the moment of fertilization, is entitled to the same rights, powers, privileges, justice and protections as are secured or granted by the laws of this state to any other human person; and treats as void and of no effect any and all federal statutes, regulations, executive orders and court rulings, which would deprive an unborn child of the right to life.

**TEXAS: Abolition of Abortion in Texas Act - HB 948** A living human child, from the moment of fertilization, is entitled to the same rights, powers, and privileges as are secured or granted by the laws of this state to any other human child. The attorney general shall direct state agencies to enforce those laws regardless of any contrary or conflicting federal statutes, regulations, executive orders, or court decisions.
