 Property Rezone/Special Use Permit Ronald Imhoff, 11157 W. Stanton Rd., Trufant, MI 49347, parcel #016-031-002-21 To conclude the process begun at the Public Hearing held on May 22, 2023

Invitations to owners of neighboring properties within 300 feet were sent. No correspondence was received in response. Three neighboring owners were in attendance - Don Imhoff, Ron Christensen, and Mike Krause. These property owners expressed no opposition to the business operating on this property.

Imhoff explained to the Commission the drawing/layout of his property and that business hours would be sunup to sundown, with extended hours as needed. No berm will be required by the Commission. A log stack height limit of 12 feet is required.

Imhoff explained that the person who made the complaint regarding his business is a competitor who has caused trouble for him in the past and explained that his belief is that all that is required for Imhoff's business to be in compliance is a Special Land Use permit.

Bill Drews explained his role as Township Supervisor and that he brought the situation to the Commission based on Township ordinance requirements that all Township residents must follow.
