In Carthage, the Kanaites called themselves Punyaks. Rome attacked Carthage in full force, beginning in 264 BC, and fulfilled its task after killing or enslaving each Carthaginian, sowing the earth in salt so that nothing could ever grow there again. The Edomites descended from Esau later married to the Turks to produce a mixture of Turko-Edomite, which later became known as the Cossacks - who are the current occupiers of Israel. These Kanans eventually adopted the name Sepharvaim for deceptive purposes. They later became known as Venetians, and married the European royal family and aristocracy, a black nobility. The Venetians now control the U.S. Federal Reserve system. Around 1400 AD, European energy centers merged into two camps: the Gibellins, who supported the Family of The Exporors of Hoensaufen, and Guelph of Welf, a German prince who competed with Friedrich for control of the Holy Roman Empire. The pope allied himself with the Guelphs. All modern history stems directly from the struggle between the two powers. The Guelphs are also called the Nerie, the Black Guelphs, or Black Nobility, and supported William of Orange in his capture of the throne of England, which eventually led to the formation of the Bank of England and the East India Company, which would rule the world from the 17th century. All coups, revolutions and wars in the 19th and 20th centuries are concentrated in the battle of the Guelphs to hold and consolidate their power, which is now the New World Order. The power of the Guelphs will be distributed through the Italian financial centers in northern France in Lombardy (all Italian bankers have been named Lombards). Lombard means a German deposit pot, and pawnbrokers were bankers for the entire medieval world. Later they move operations north to Hamburg, then to Amsterdam and finally to London. Guelphs began the slave trade in the colonies. Guelphs, to help control their finances and policies, would perpetuate the Gnostic cults that eventually turned into Rosicrucians, unitarians, the Fabian Society and the World Council of Churches. The East India Company, together with John Stuart Mill, will fund the University of London. Mill's friend, historian George Grote, founder of the University of London, has donated 6,000 pounds to the study of mental health that began around the world by the mental health movement. Banks large and small in thousands are on the Committee of 300 networks, including Banca Commerciale d'Italia, Banca Privata, Banco Ambrosiano, Bank of the Netherlands, Barclays Bank, Banco del Colombia, Banco de Ibero-America. Of particular interest is Banca del la Svizzera Italiana (BSI) - as it processes flight capital investments in and out of the United States - primarily in U.S. dollars and bonds - located and isolated in neutral Lugano, center Venetian Black Nobility. Lugano is not in Italy or Switzerland, and is a kind of twilight zone for shadow operations of flight capital. George Ball, who owns a large block of BSI shares, is a prominent insider and representative of the bank in the United States. In the secret Treaty of Verona of 1822 (between Austria, France, Prussia and Russia), the Jesuits agreed to break the U.S. Constitution and suppress U.S. freedom. Their methods included the destruction of free speech, the destruction and suppression of the press, universal censorship, the maintenance of the cooperation of the Pope and the clergy using religion to keep nations in passive obedience and financing wars against countries with representative governments. The monarchs who signed the treaty were eventually overthrown. Most of these families are very rich and may be more powerful today than when they were sitting on thrones. They are known collectively as Black Nobility. Privately, these families refuse to recognize any right to rule except their own. The fact that the treaty had been made a long time ago did not mean that it was invalid. The treaty was included in a congressional report on April 25, 1916, by Senator Owen. In 1948, George H.W. Bush graduated from Yale University and Skull and Bones. He is a distant cousin of the queen of England, part of the Black Nobility, which traces its power 5000 years. Prince Bernhard of the Netherlands created the group that became known as the Bilderbergers. Many conservative researchers began to recognize the Bilderbergs as an important force for the

New World Order. (Note: Since the Bildebergers, according to former British intelligence agent John Coleman, serve as a binding force between three major single world government forces - the Wicca Masons (i.e. communism); the Black Nobility descendants of the early Roman emperors; and the Maltese Jesuits. . . each has 13 relevant representatives on the 39-member Bildeberger board - and since the Nazi SS stormtrooper was responsible for the design of this New World Order Coordinating Council, and since Adolf Hitler's second book has been titled Believe or No new World Order. Unsurprisingly, Adolf Hitler's dream - and his Kaiser predecessors, the German translation of Caesars - was the rebirth of the Roman Empire. According to former British intelligence agent Dr. John Coleman, the three world power groups: the Wicca Masons (i.e. communism), the Maltese Jesuits and the black-nobility (Black in this context refers to their character, not their skin color) are all works and under the central command of the Bavarian Illuminati, which binds them together. To do this, the Bavarians created the Bilderberg Club, the core of which is a board of 13 members from each of the three groups or 39 in total. Old ruling families who believe they have a right world because they they they from the emperors of the Roman and so-called holy Roman empires consist of 13-15 families of blue blood. The history of the Bilderberg Club itself, the cover for the Bavarian Illuminati, and its Nazi cones, is likely to be the best place to start. Prominent on the board are two insurance giants committee of 300 members: the Giustiniani family, the Black Nobility of Rome and Venice who trace their line to the Emperor Justinian; Sir Jocelyn Hambro of Hambro Bank (trading); Pierpaolo Luzzatti Fequiz, whose pedigree dates back six centuries to the most ancient Luzzatos, the Black Nobility of Venice, and Humberto Ortolani of the ancient black nobility of the same name. The other old Venetian Black Noble Committee of 300 members and board members of ASG and RAS are the doria family, financiers of the Spanish Habsburgs, Elie de Rothschild from the French Rothschild family, Baron Augustus von Fink (Fink, the second richest man in Germany, now deceased), Franco Orsini Bonaxi from the ancient Orsini of the Black Nobility, who traces his ancestry from an ancient Roman senator of the same name, the Alba family, whose ancestry dates back to the great Duke of Albe, and Baron Pierre. Italy was selected as a test target by a 300-member Committee. Italy is important to the conspirators' plans because it is the closest European country to the Middle East and is linked to the economy and politics of the Middle East. It is also the home of the Catholic Church, which Vaishaupt ordered to destroy, and home to some of Europe's most powerful oligarchic families of the ancient Black Nobility. If Italy were weakened by the death of Aldo Moro, it would have consequences in the Middle East that would weaken U.S. influence in the region. Italy is important for another reason; it is a gateway for drugs coming into Europe from Iran and Lebanon. Various groups have banded together under the name socialism to lead to the downfall of several Italian governments since the Roman Club was established in 1968. Among them are the Black Nobility of Venice and Genoa, P2 Freemasonry and the Red Brigades, all working for the same purposes. Police investigators in Rome working on the Red Brigades-Aldo Moro case have stumbled upon the names of several very famous Italian families, working closely with the terrorist group. The police also found evidence that in at least ten cases these influential and prominent families were allowed to use their homes and/or property as safe houses for red brigade cameras. To introduce new cults and continue to encourage those already functioning, that includes rock music gangsters such as the messy, degenerate Mick Jagger in the Rolling Stones (a gangster band much favored by European black nobility) and all Tavistock created rock bands that began with the Beatles. To continue to build the cult of Christian fundamentalism initiated by the servant of the British East India Company, Darby, which will be used for other purposes to strengthen the Zionist state of Israel by identifying with the Jews through the myth of God's chosen people and donating very substantial sums of money to what they mistakenly consider to be a religious cause in the development of Christianity. The same Sustel was a contact man from the Guerrilla Group of Sendero Luminosa-The Shining Path, which protects Peruvian cocaine producers. Richard Gardner was sent to Rome on a special mission. Gardner married one of the oldest families of the Black Nobility of Venice, thus giving the Venetian aristocracy a direct line to the White House. The late Averill Harriman was another of the committee's direct ties to the Kremlin and the White House, a position inherited by Kissinger after Harriman's death.
