Residency Visa for Immigrant Entrepreneurs

The D2 visa, also called the Visa for Immigrant Entrepreneurs, gives resident status to immigrants who plan to involve themselves in investment activities in Portugal. The legal basis for this type of visa can be found in article 60(2) of Law No. 23/2007 from July Four, and regulated by article 31(2)(3) of Regulation Decree No. 2. 84/2007 from November 5 and Paragraph Two of this article Eighty nine was amended by Law No. 2. 59/2017, pf07/21 and fourth amendment to the Aliens act in force since First August' 2017. 
