

International Company Incorporation

Service Proposal

Company Registration

Setup a single limited liability company, i.e. Besloten Vennootschap (BV) company in the Netherlands.

In person incorporation	€ 1500 Euros
Remote Incorporation	Extra €300 Euros

Inclusions: Company name search, notary charges, unofficial translation of draft company deed and ODI's fees. The above price is based on registration of a single shareholder/director

Exclusion: For each additional Shareholder/Director (maximum 4) a fee of €250 is chargeable. Documents apostle charge for each Shareholder/Director of €100. Individual director registration at Dutch Chambers of Commerce is charged at €50 each.

Domiciliation/Office for Company Registration

We have a network of more than 60 partner office locations throughout The Netherlands. Registered office address is a mandatory requirement to set up a BV company.

Inclusions: A Virtual office desk in a co-working space (no private cabin). The office address is used as the substance requirements set by the Dutch tax authorities. The price includes single person access to internet/Wi-Fi and general refreshments. Service contracts to be executed by third-party office providers.

Exclusion: The mail processing is mostly executed. This can be added to your service by personal request at an additional cost of **€1.00 per scan copy** Mail forwarding courier charges are also charged as per actual. The above price does not include private office space. Meeting rooms, meals, and teleconferencing facilities are charges extra as per business center rate list. **Office Setup Fee:** One-time office setup fee equivalent to **one month rent** is applicable. **Security Deposit:** Deposit at the time of signing equivalent to **one month rent** is applicable.

We can set up a **Dedicated Business Landline** with +31 telephone number with call forwarding facility to your **International Mobile Number**. By activating this service, you will **'never miss an important business call'** regardless of your physical location.

Business Accounting Service

This service concerns the application of the VAT number and 12 hours of ongoing tax. Preparation and filling of first VAT Questionnaire from the Dutch tax authorities. Preparation and filling of 4 VAT returns. Preparation and filing of the Annual Report and filling of the corporate tax return. Under this service we will assist you with your invoice formats and provide you a dedicated email address to send your sale/purchase invoices for maintaining records, Processing of up to 15 sales/purchase invoices is included in the following price. Additional invoices processing charged at €2.50 each.

Opening Bank Accounts

To Start the Procedure

To Start the Procedure

We will require the following documents and information to begin the process.

- Passport copy of each Director/Shareholder.
- Proof of the address (e.g. utility bill) of each director and the shareholder.
- Completed DataForm.

Once we receive client's request to incorporate, a Proforma Invoice is sent to approve for chosen services. Company incorporation starts only after we have received a 50% advance payment from the client. Clients are required to sign a Power of Attorney (POA) in favor of the Dutch notary in case of the remote formation. All directors identification documents, data cards, and POA have to be legalized and apostilled by a foreign notary. Please note, in person company formation takes 4-6 working days and remote company incorporation takes 10-15 working days from the date of receipt of the advance payment. The incorporation time is subject to authorities' scrutiny and may take longer than usual in some cases.
