Mr B Rosen – Having visited Rockham Beach and seen numerous holiday makers scrabbling down the cliff, Mr Rosen enquired about the progress of plans for the provision of proper access to Rockham Beach. *Councillor Wilkinson stated that the subject would be raised as a priority with the A.O.N.B and formally raised with the National Trust. The cliffs had been recently surveyed by Devon County Council but budget restrictions curtailed work on the creation of any new access.*

A Shelley - Ms Shelly reported on her attendance at the Inaugural Meeting at the Castle Centre in Barnstaple on the 'Housing Crisis in our Community' and enquired about news on the Braunton Parish Council press announcement on the Housing Crisis which was supported by Mortehoe Parish Council at the August meeting. *Councillor Wilkinson reported on the statement made by the Leader Of North Devon Council on the subject.*

73427 Removal of caravan, demolition of office & storage building together with erection of 2 units of holiday accommodation at Woolacombe Riding Stables Eastacott Farm Beach Road Woolacombe Devon EX34 7AE

Members supported this application and had no objections to the proposal. They also recognised the importance of the development in support of the adjacent local business. *Proposed APPROVAL. Seconded*. *PASSED UNANIMOULSY*

73913 Extension to the front of the property at 13 Kingfisher Woolacombe Rise Woolacombe Devon.

Members had no objections to this application. *Proposed APPROVAL. Seconded. PASSED UANANIMOUSLY.*

73926 Double height extension to the South West elevation. at Ferndale North Morte Road Mortehoe Woolacombe Devon

Members expressed a number of concerns regarding this application:

- 1. **Over-intensification -** Members were concerned at the height, mass and bulk of the proposed building and felt that should be regarded as gross over-intensification of the plot.
- 2. **Privacy Issues** members felt that 3 storey proposed extension would lead to privacy and overlooking issues for nearby properties and a loss of amenities for a number of neighbours.
- 3. **Parking** it was felt that the loss of the existing garage would further exacerbate the parking issues for the property and would prove inadequate for another large extension.
- 4. Access and egress Members felt that the proposed parking arrangements for 3 separate properties was inadequate for safe access and egress onto the very narrow and busy North Morte Road.
- 5. **Street Scene** members felt that the proposed very large building was out of keeping with the existing street scene and pointed out that the original property on the site had been a single dwelling in proportion with its surroundings.
- 6. Existing Utilities Members felt that the existing utilities were inadequate to serve a building of this scale and were already under pressure from the many developments that have taken place in North Morte Road in recent years *Proposed REFUSAL. Seconded. PASSED UNANIMOULSY.*

Update – Dug-Out - the clerk informed members that following the disbandment of the Woolacombe & Mortehoe Football Team this week, the remaining building material and loose blocks have been removed from the Meadow and taken up to the Woolacombe Sands Holiday Park. A decision regarding the building work already commenced for the dugout was deferred.

Cutting of the Pitch - the pitch is currently being cut on a fortnightly basis. The clerk informed members that future cuts will be timed to coincide with the fixtures of the remaining football team AFC Dominii.

Junior Team – Mr Adam Dennis will be setting up a Woolacombe Youth Team and will be using the Junior pitch for training and the astro pitch at Braunton for matches. He is hopeful that he has business sponsorship for kits and equipment.

Skateboard ramp – **new all-weather surface.** – *Councillor Dicker informed members that the huge increase in prices for materials meant that it may be prudent to delay obtaining quotations for improvement works for the facility.*

Skateboard Fun Day September 19th – *Members congratulated all concerned in the very successful event held the previous day on the Meadow*
