DISCUSSION OF SOLAR ORDINANCE LEGAL RECOMMENDATIONS (attachment)

The following corrections and updates were made:

- Page 1 The colons that were to be added to the numbers 203 and 204 were not added and this still needs to be done.
- Page 2 Gorby moved, supported by Nadeau, to remove the Prime Farmland definition, as there is no longer a reference to prime farmland in the ordinance.

- Page 3 16.04 1. e add "d" to the word "use"
- Page 4 2 c.

Nadeau moved, supported by Gorby, to make the following change the final sentence of Page 4, Section 2, subsection c: Such proof shall be subject to the (*omit Township*) Building Official's approval.

- Page 8 16. & 21. Christensen moved, supported by Nadeau, to change the word "applicant" to "applicant/owner/operator". MOTION PASSED.
- Page 11 e. Decommissioning Plan 1.

Nadeau moved, supported by Gorby, to change the word "applicant" to "applicant/owner/operator". MOTION PASSED.

Gorby moved, supported by Main, to insert the word "additional" between the words "any" and "agreement". The sentence will begin "Description of any additional agreement".

- x. owner/operator will be changed to applicant/owner/ operator.
- Page 12 g. Nadeau moved, supported by Buchholz, to change the word "applicant" or "owner" or "operator" to "applicant/owner/operator" in all sections of the Ordinance pertaining to Level 2 and Industrial Solar Operating Systems. MOTION PASSED.

Gorby moved, supported by Buchholz, to change "owner/operator" to "applicant/owner/landowner" to be consistent with letter "f". MOTION PASSED.

- Page 13 Nadeau moved, supported by Gorby, to change the wording in letter i. And in 4. from "applicant" to "applicant/owner/operator". MOTION PASSED.
- Page 14 Nadeau moved, supported by Gorby, to correct the numbers of Sections 4, 5, 6, and 7 due to Section 3 having been omitted. What was 4, 5, 6 and 7 will now be 3, 4, 5, and 6.

Gorby will send the changes to attorney Abdoo so all changes will be on record in that office and the final draft can be reviewed. If the document has been returned by the March 13, 2023 Township Board meeting, Nadeau will ask for the proposed ordinance to be posted on the Township website.

Main moved, supported by Christensen, to schedule a public hearing on the proposed solar ordinance for Monday, April 10, 2023 at 5:00 PM MOTION PASSED.

Linda Reynolds, Stanton - Commended the commission members for working well together
