## Muskegon county clerk of courts

If you plan to come to our office, please contact us that you will have to undergo a short health screening procedure, which includes taking the temperature and answering a few questions. You need to wear a mask or face covering at all times. Due to the limited space inside the offices, you must complete all your requests/applications before you are allowed into the office, including ID and payment complete. Keep in place to remember that offices close at 4:30 p.m. and some services can take up to 20 minutes to complete. Allow this when you come into our office. The Online AV app has been updated to include the ability to request an easy-to-use AV vote for voters who are blind or otherwise severely disabled. On the Contacts page of the Online AV app, voters can select a box that says I ask for an accessible ballot and then select another box stating: I report being blind or otherwise severely disabled, and that such disability prevents me from being powered privately and independently to run an absentee ballot on paper without visiting the clerk's office. The Send page in the Contacts section contains confirmation of whether an available ballot was requested. Do you need to renew your license soon? If you want to get a REAL ID-compatible one that will be used for flying after October 1, 2021 (under federal law), bring these documents with you to the Secretary of State's office for the first time so you don't have to make multiple trips.
