Mr. Kamei started his career in 1978 working for Toyo Engineering Corporation, where for 20 years he was responsible for IBM computer systems, plant computerization and creating and developing corporation network. Successfully managing key projects and the experience he gained became his core skills that proved to be invaluable in his future endeavors.

In 1988, he joined the Advanced Science, Technology & Management Research Institute of KYOTO (ASTEM), founded by Kyoto City, Kyoto University, and the industry, supporting the establishment of the Institute and later its management.

His experience with establishing research institute and translating the research into business resulted in invitation to establish ISIT in 1993, a similar enterprise founded by Fukuoka City and Kyushu University.

In 1994 with the beginning of internet in Japan, Mr. Kamei saw an opportunity to use the newest world development for business and played a crucial role in introducing and developing the network into Japan. This skill was noticed by Softbank, and after bringing Mr. Kamei onboard, Softbank nominated Mr. Kamei the CEO and COO of three venture companies under aegis of Softbank. The companies were developing then innovative platforms related to inter alia eLearning and eBook

Mr. Kamei has learned about OIST (Okinawa Institute of Science and Technology) from a friend, and seeing a great potential in world class institute and opportunity for Japanese market in translating the technology into business, he decided to join OIST in establishing the first startup from the Institute, Okinawa Protein Tomography Ltd.
