Therefore, the best way to find a prisoner is to call at 864-898-5534 and do a direct investigation to a prison officer. When communicating with a prison staff, you should enter the first and last name of the inmate or ID number or date of birth correctly. It will get you quick results. Important Jail policies and procedures Under the visiting policy of Pickens County Jail, each inmate is given one hour of visit sessions per week. Inmates can meet a maximum of three visitors per session. All visitors must be accepted by visitors as the prison administration schedules each session based on the visitor list, filled in by the inmates. Visitors must submit a valid photo ID as proof of id. Upon arrival at the resort, visitors must go through a pat-down search procedure. You can communicate with a prisoner if you send mail via US Mail. When writing internal mail, be sure to include the following postal address and template: Please note that all mail received through Friday and the prison administration would open and inspect any incoming or outgoing mail for contraband. You can deposit money if you use the kiosk machine, located in the lobby. The machine accepts cash or credit card deposit. To deposit money, you will require the MNI number of the inmate. You can find the MNI number in a notebook, located near the bank kiosk. You can also deposit money using a mail mail. Other than this way, you can go online and deposit money directly into a prisoner's commissary account. You must accept a disclosure to access information from the database. Bail and Bondsman You can save a prisoner from Pickens County Jail if you put bail money to the court. A castle is a form of property, which can be in cash or collateral. The bail money is determined according to the court's bail plan. The court will decide how much money to pay as fees for the crime they have committed. If you can't afford to pay bail money, you should hire a bail and bondsman. A licensed bail and bondsman would send bail money for you and charge at least \$100 as their premium. Pickens County Probation Department Probation officer's is appointed to investigate, report on and oversee the execution of convicted felons on probation. Items to bring to the Probation Office include: employment control (a salary stub), residence (a lease, copy of an electricity bill, etc.), community service record log, counseling or meeting attendance, all personal drug prescriptions, medical condition documents, and immigration registration among others. Before we start discussing the various tools to help you find your loved one, let's quickly clarify that you need to have some important identifying information at hand to do so. This information includes: Your loved one's full legal name (first, middle and last) Their date of birth It states that they are kept in Note that certain tools may suggest or require additional information from you about your loved one, depending on individual circumstances As we review this list, we will make clear what this information is, and where it is applicable. Now, for the inmate's localization tool. As we said, BOP's search tool only shows results for federal prisoners. To find a prisoner being held in a local or state prison, you want to use the government website for in which your beloved is located. While we won't take you through the step-by-step process of finding a prisoner in each state, let's take a look at a few examples: Here's what you need if your loved one is imprisoned in New York: Note that Department ID Number or New York State ID Number are intended to be used on their own. In other words, if you include any of these numbers, you don't need to include the inmate's name and year of birth. Similarly, in order to find a prisoner in California, you need to enter either their full legal name or their Internal Number if you know it. While most states provide the opportunity to search for a prisoner on their official government website, others use a third-party search tool, which we will discuss in the next section. The Bureau of Prisons allows you to search its database of federal prisoners to find your loved one and to reveal their contact information. Please note that this database covers only inmates held in federal prisons – we come to smaller prisons and prisons in an instant. Bop's database also contains information about prisoners who have been released, dating back to 1982. When you use bop's search tool, you can search for a prisoner by name or with a variety of identification numbers. Let's first search for an inmate using their name: Again, searching for a common name without any additional information leads to a large number of search results. Also, note that the search engine limits the number of results to 100 – meaning a bunch of other inmates named John Smith don't even show up. Obviously it is not likely that you will face this issue, but it is definitely good to know. In any case, you can also narrow down your search by including your loved one's race, age and sex. Because this search tool does not offer advanced search capabilities, you may need to include this information to see less than 100 results. You can also search for a federal prisoner using a number of different identification numbers, such as: BOP Register Number CDC Number FBI Number INS Number Because these identification numbers, of course, belong solely to your loved one, using this method is the best way to generate accurate results from the BOP's website.
