- According to a report by Research Dive, the meat product market in Southeast Asia is projected to exceed \$117,259.2 million by 2026, with a compound annual growth rate (CAGR) of 5.1% from 2019 to 2026<sup>1</sup>.
- Pork meat products are predicted to experience the highest growth among the various meat types, with an estimated value of \$43,636.9 million by 2026.
- The Thailand market is expected to offer lucrative growth prospects for the meat product
  market during the forecast period, with a projected CAGR of 6.5%. This growth can be
  attributed to factors such as stringent regulations governing animal diseases and food
  safety, advancements in farm productivity, and the increasing development of meat
  products in other Southeast Asian countries.
- In 2019, the meat market in Vietnam generated \$30,671.7 million, and it is anticipated to increase to \$44,155.2 million by 2026. The substantial growth of the Vietnam meat market can be attributed primarily to significant investments made by market players to develop innovative meat products.
