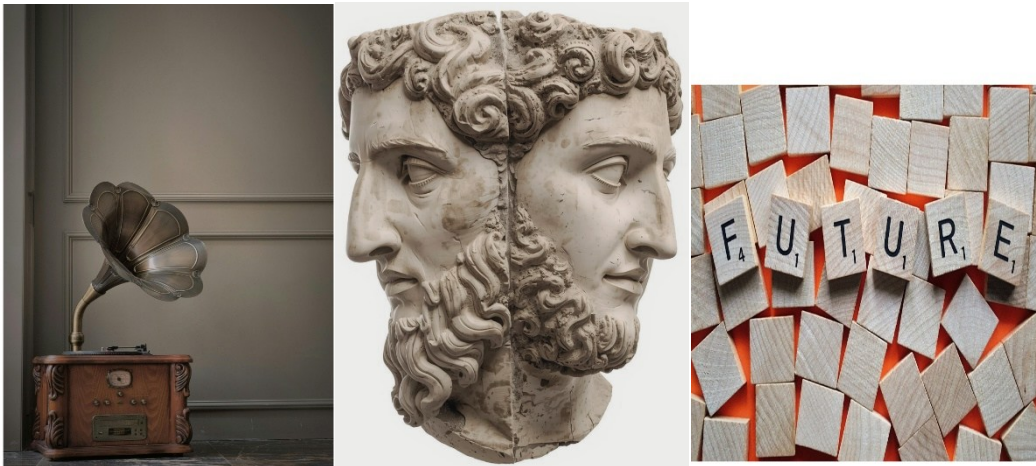

## **II. A look back**

In August 2022<sup>1</sup>, we, V a l v o, Claudio, and S a u e r, Sandra, decided to establish an LLC in the US state of Wyoming to give our business the necessary freedom and legal framework. We were aware of our skills and abilities and wanted to offer them to the outside world.

We also agreed that we wanted to offer our services independently and on a freelance basis, without being bound to any associations or organizations. This important decision was incorporated into our company philosophy.

The decision to establish an LLC was not easy and involved research and information gathering, as well as debates and discussions among the prospective partners. Ultimately, we decided to go ahead with the formation, choosing an LLC in Wyoming rather than a British Ltd., a German UG, or any other legal structure.

Before the LLC was founded in Wyoming, several important matters had to be clarified, such as the name of the newly established company. The company was to be called VISCORSOL LLC. Why and what does "VISCORSOL" mean? The name VISCORSOL comprises several syllables, each with its own meaning.

"VIS" is short for "visions" and represents the creation and development of visions and goals, as well as awareness. The syllable "COR" stands for the Latin word for heart and is meant to express the power of the heart, passion, and creative energy, as well as one's own conviction towards oneself and others. The syllable "SOL" contains the English word for "solution" and represents the implementation and realization of visions, but also the development and exploration of paths and solutions that lead to the goal and the vision.

Further steps included setting up the digital structures in the data space for VISCORSOL LLC, such as opening an email address and creating a public platform, like a website. Now the decisive step had arrived: the founding of VISCORSOL LLC in the US state of Wyoming, independently and digitally, from the Federal Republic of Germany.

Ultimately, the sacrifices and investments have paid off. We can proudly say today that our company has been on the market for almost four years and has set quite a few things in motion, both in the public sphere and for one or two customers.

## **III. A look ahead**

And yet, we don't want to rest on our laurels, but rather look to the future. What can we do and be to attract even more customers and create even more positive momentum?

As already mentioned, we have redesigned our website and expanded our range of services. Furthermore, we have restructured our service portfolio and made it more transparent for our customers.

### **1. Consulting and incorporation of an LLC in the USA**

The core of our services remains advising on and facilitating the formation of LLCs. We believe that, given the current situation, establishing an LLC in the USA makes sense and relieves future entrepreneurs of unnecessary bureaucracy and technical burdens, especially since the political landscape in the USA has also changed. Furthermore, the LLC remains the right approach when it comes to protecting personal assets from business risks and minimizing tax burdens compared to European or German corporate structures. While the question used to be, "Which tax system offers the greatest financial advantage for the company?", today it's more about "Which tax system imposes the least amount of tax and bureaucracy?"

### **2. Business and management consulting**

Furthermore, we offer business and management consulting services, utilizing our proprietary tools for economic, legal, and data protection analysis, as well as mentoring. Our focus is on sole proprietors and small business owners, but also on individuals who want to gain an understanding and overview of their economic situation. However, the term "tool" should not be misunderstood. It's not about downloading an app, entering data, and expecting the business or personal situation to magically resolve itself simply because some algorithm has generated a new model. Rather, the term "tool," as the English word suggests, refers to tools in the

truest sense of the word—analytical tools provided to the client to work with and understand their economic situation. Only through awareness can a comprehensive overview be achieved, which then enables discussion and exploration of solutions for optimizing the economic situation.

### **3. Business correspondence**

We will continue to handle correspondence in business and contractual matters. We will manage correspondence with other companies, authorities, or public bodies on your behalf.

In doing so, we can draw on a wealth of expertise in communication and correspondence management. We advise our clients on the best approach to achieve their desired goals. We correspond in multiple languages, not only German, but also English, Italian, and French. Our work is based on facts and evidence, not on assumptions, speculation, or models.

### **4. Correspondence in matters of white-collar crime**

Furthermore, we have decided to expand our correspondence services to include matters of white-collar crime, as we consider it important to support the process of rectification in economics, academia, and society. Our services encompass the investigation and research of white-collar crime cases, as well as the preparation of criminal complaints, reports of administrative offenses, and notifications of misconduct by public authorities. Here, too, our work is based on facts and evidence, not on assumptions.

### **5. Preparation of medical, nursing and medical-legal expert reports**

In light of the increasingly clear truth about the 2020 lockdowns, including medical malpractice and coercive measures, we have decided to prepare expert medical-legal reports. Our services include the preparation of medical-nursing and medical-legal reports that can be submitted to public bodies and authorities as evidence. Our reports are prepared on a freelance basis and are independent, as we are neither members of any professional association nor affiliated with any other organizations, associations, or political parties. Furthermore, we aim to contribute to the clarification and analysis of the lockdown period and the coercive measures.

## **6. Data law and data protection with data awareness**

Our range of services related to data law and data protection with a focus on data awareness will, of course, remain an essential component of our natural law philosophy. However, we have made some changes to our service offerings.

In the future, information about personal data will be offered at a fixed price. The service itself remains the same: VISCORSOL LLC, acting on behalf of the data subject, requests information about their personal data and requests that this information be sent to them either electronically via email or by post. It is important to us that our clients retain control over their own personal data.

All other activities and assignments related to data law, in particular the enforcement of data protection rights, will be provided on a fee basis. It is important to emphasize, however, that access to personal data is a fundamental requirement for most data protection rights and therefore takes precedence over the enforcement of these rights.

## **7. Courses on data law and data awareness; courses on communication and contract law**

Upon request, we offer virtual courses on data law and data awareness to raise participants' awareness of data protection law, particularly given its intrinsic impact on contract law.

Furthermore, we aim to empower participants to understand their own personal data and the data space within it, enabling them to make independent and informed decisions regarding its handling. We have also decided to offer additional courses, such as those in communication and contract law.

## **8. The Freigeist magazine and its publication**

Now we come to our new, yet familiar, magazine, the Freigeist Magazine, which will be published monthly and run under the umbrella of VISCORSOL LLC. Those familiar with the Freigeist website know that it has featured articles on natural law topics. We have decided to build on this and publish a Freigeist Magazine both on the Freigeist website itself, on the VISCORSOL LLC homepage, and on other platforms.
