CHAPTER I JURISDICTION OF LONE JUDGES AND THE BENCH OF THE HIGH COURT 1. Judicial jurisdiction is usually exercised by the District Court of two judges. The Court's civil and criminal jurisdiction on the appeal side, except where it is otherwise provided by these rules, is exercised by the District Court, which consists of two or more judges. 2. Issues disposed of by a single judge. - To save, as otherwise expressly provided by these rules, one judge may dispose of the following questions: - I. Civil - a) Appeals. (i) From the original decree in claims or from adjudication in other proceedings of which appeals lie in the High Court, as of the original rulings, whether in accordance with the Civil Procedure Code or under any local or special law, in which the value of the item in a dispute in the Court or Tribunal of first instance does not exceed 10 rupees and in which the value of the item is still in dispute less than 10 rupees; provided, however, that the expression of the value of the item is still in dispute on appeal, appearing in this subcategory should be 1.
