

IS THE KING OF KINGS ALREADY HERE?

Overview

There is a man alive today named *Alexander Nikolaevich Paramonov*.¹ He is Russian and lives in Russia. He reportedly inherited – through a spiritual event – an *astronomical* amount of wealth, including, but not limited to, over *five billion* metric tons of gold (which is being stored in underground vaults, protected by extraordinary technology). He also claims to have inherited control over, and ownership of, the entire world financial system. He has consolidated his wealth in an organization called the Sovereign International Treasury Monetary One (“SITM1”) (monetaryone.org).

But Mr. Paramonov is not using that fund to make more money (as most financial funds do). He is using that vast wealth to reshape the world we live in, to create a much better world. One in which justice and truth prevail, and spiritual growth for all of humanity can occur.

Mr. Paramonov is a spiritual and worldly leader. He speaks prophetically about the future, and with knowledge about the past and on a range of subjects. He acts in ways that indicate that he is taking responsibility for the state and fate of the world and humanity. And he is taking actions to drastically and fundamentally improve our world.

He speaks with strong indignation about the “powers-that-be” (the super rich and powerful people who control nations from behind the scenes), who are attempting to: instigate WWII; corrupt and pervert humanity; and greatly reduce the human population. Mr. Paramonov refers to them as the “enemies of mankind.”

He has also stated that fundamentally they (the enemies of mankind) really have just one tool which enables them to control humanity. And that is their control over our financial system. Therefore, it is right in that one area – that of the world financial system – that Alexander Paramonov has chosen to fight. He has developed a new, gold backed financial system for the whole world which the Satanic powers-that-be cannot control. (This new system will replace the current, corrupt system.) After about five years of work, in October of 2025, that new system was finally completed (or largely completed).

A part of this work involved Alexander Paramonov cutting off access to certain very large – exceedingly large – ancient funds which the powers-that-be had gained (limited) access to and were using to empower their fiat currency financial system (the current financial system).

Some of the assertions of facts in this article have footnotes which source those assertions by referencing to (time stamps for) points made in some of the videos about Alexander Paramonov from the Zlata Era Youtube channel. Some readers might react to such references by saying that just because someone says something in a video doesn’t mean it is true. I acknowledge that. I am not presenting those references to the videos as solid proof of certain facts. Rather, I present those references because the reader might wish to review the source of that assertion and the context in which the source assertion (in the video) was made.

Also, to the extent that the reader trusts the truthfulness of these videos, especially if it is Alexander himself speaking in a given video, these sources in the videos provide supporting evidence for the assertion in question.

He states that these ancient funds were held by the White Spiritual Boy Corporation and they always belonged to the Divine Powers. But the Satanic powers-that-be had nonetheless gained limited access to these funds.

But just recently (in about 2021) Alexander Paramonov cut off the access to these immense funds (that the powers-that-be had) and transferred all of them into his new financial organization, the SITM1. He issued formal decrees that all such access that the powers-that-be had previously to these funds has now been cut off. Copies of these decrees were sent by him to central banks and other entities in numerous countries around the world. Alexander stated (in 2022), that consequently all these fiat financial systems are already bankrupt.²

But, as stated above, he has created a new, gold backed financial system, which he (and others who are working with him) has (have) been creating over the past five years (from about 2020 through 2025). As part of this new financial system, Alexander has issued three new gold backed currencies: The Golden US Dollar, the Golden Soviet Ruble, and the Golden Ecu. Every unit of each of these currencies is redeemable for 1.2345 grams of gold. He has also established the SITM1 as the “main mega-regulator of the Global Financial System.”

He has also created the Sunrise Program. In that program any group of people anywhere in the world can apply to open a “cooperative,” an organization with a wholesome community, which is organized under international law, is sovereign and not subject to taxation, and which includes a special type of bank which utilizes gold backed money (and which is connected to and backed by the SITM1). One of these “cooperatives” has been established in Slovakia (<https://spdr.sk/en/home/>) and there are others in other countries as well.

It is my understanding that these “cooperatives” provide annuities for all of their members, which (apparently) means that none of the members will have to worry about earning money to live any more. It is also my understanding the members are expected to work, but they can work in whatever way or field that they want to which makes a positive contribution to the community. Thus, these cooperatives are helping to create a wonderful, new Golden Age in which each of us will be able to live our lives in very fulfilling ways.

Alexander Paramonov’s new gold backed financial system will soon replace the old fiat currency systems and then the powers-that-be will lose their power and control over humanity. And what will then happen to the powers-that-be? Alexander states that those among the powers-that-be who manage to survive into the time of the New Golden Era will be prosecuted and punished for what they have done.³

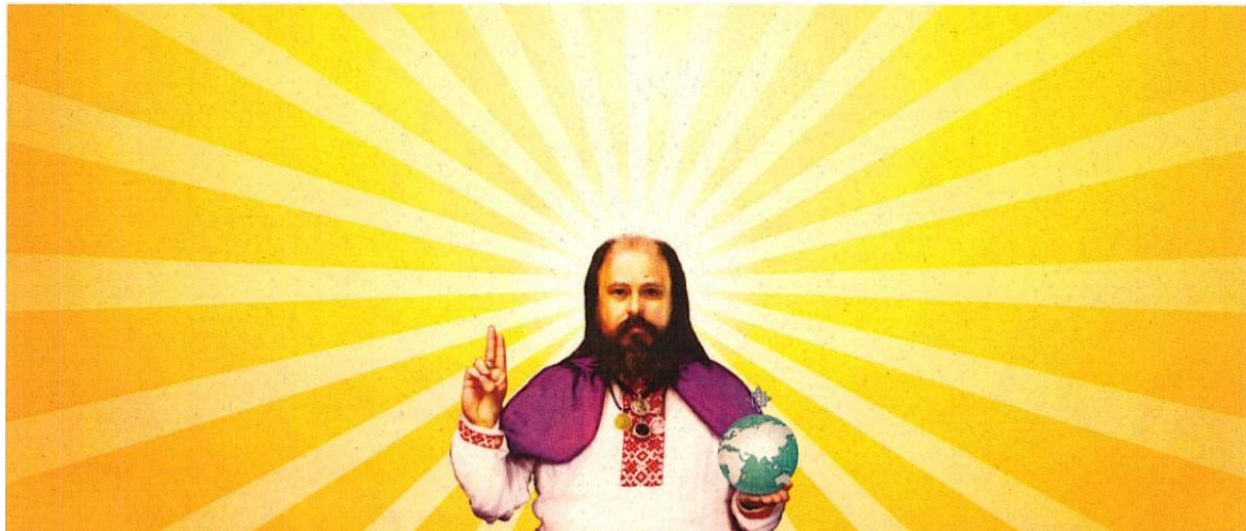

Who is Alexander Nikolaevich Paramonov?



Given the information in the Overview section, above, a key and extraordinary question which arises here is: Who is Alexander Nikolaevich Paramonov? Is he really completely revolutionizing the world's financial system? Is he really going to break the power and control that the Satanic powers-that-be (the Rothschilds, the Rockefellers and others) have over humanity? Is he really going to set up a bright, new excellent world?

And the ultimate question here is: *Could this be ... Jesus Christ, who has finally returned to restore justice, reclaim this world and create the promised Kingdom of God????*

Let us seriously consider this question and examine it from various angles:

Please keep an open mind while considering this matter

First of all, I think it is very important for the reader to consider this question – Is Alexander Paramonov the Christ? – with an open mind. This topic is of great importance, obviously, and it is also very personal for many of us. It is personal (partly) because it involves our own views – and preconceptions – about a topic which can be imagined in many different ways, and we may have tailored or chosen our preconceptions about this issue to suit our own religious desires and preferences. And so people could be very touchy about their views on this (on what it will look like when Christ returns) and they may not want to consider that their preconceptions on this subject could be wrong. (e.g.: “No! When he comes I will know it immediately and he will take all the good Christians – like me – and bring us up into the sky, right to heaven. That is how it will be. Don’t tell me anything different!”) I urge each reader to keep an open mind, to make an actual effort to restrain his or her mind from snapping shut with knee-jerk reactions (e.g.: “If Alexander Paramonov said *that* then he *cannot* be the Christ, period!”), and then to *take some time and genuinely investigate* this question before reaching a conclusion. This issue is simply too important to be addressed in an irrational, closed minded or careless way.

So I ask the reader to keep an open mind while we examine this issue together:

Alexander Paramonov is acting in the role of the King of Kings,
and doing so consistently; and this is evidence in and of itself

One of the biggest reasons to conclude that Alexander Paramonov is the Christ is that he is acting in the role of Christ. He is actually doing it before our eyes! He has created a new gold-backed financial system, he is taking away from the Satanic powers-that-be their control of the world's financial system, and thereby taking away their power and control over humanity. And, in doing this, he is working to create a bright, new Golden Era.

Is this the long promised "Kingdom of God," being created right in front of us?

And Alexander Paramonov has been working to create this bright, new world with consistency and steadiness of purpose sustained over time, from about 2020 (or earlier) to 2025. And he is not just doing relatively easy things which many others could do, such as giving speeches and managing a spiritual movement. He is *replacing the financial system of the entire world*. This is no trivial feat. And I think it is safe to say that there is no one else (or at least no one who we can readily see) who is acting on a path with such a noble aim, with a plan which (if accomplished) realistically could free us (humanity) from our Satanic overlords.

The fact that Alexander is acting in this extraordinary way is evidence which tends to support the conclusion that he is the Christ.

Let's address several facts about Alexander Paramonov which may at first appear to be
obstacles preventing reasonable minds from concluding that he is the King of Kings
but which can actually be explained as not being such obstacles

Let us consider several facts relating to Alexander Paramonov which might seem to not make sense and/or which might seem to function as obstacles, preventing a reasonable mind from concluding that he is the Christ. I will show that each of these points can be explained to show that it need not be such an obstacle:

1) Apparent obstacle:

Revelations 1:7, Matthew 24:30 and Acts 1:9-11 all seem to indicate that when Christ returns it will be from the sky and in dramatic or extraordinary fashion. These passages seem inconsistent with the notion that Christ is living amongst us in human form today (in 2025), managing a financial fund, without there being any evidence that he arrived from the sky in dramatic fashion, and with most of the world's population not knowing about him.

My response:

The (apparent) fact that Christ will appear to many in the sky when he returns does not preclude the possibility that he could also be here on earth prior to that point.

2) Apparent obstacle:

Conventional wisdom in Christian circles is that Christ will not return until the end of the age, until the Great Tribulation has occurred and ended. Since that has not yet occurred, how could Christ be here now (in 2025)?

My response:

The answer to this question (this apparent obstacle) is similar to the previous answer. The fact that Christ will return at the end of the age, when the Great Tribulation is over, does not preclude the possibility that he could also be here on earth prior to that point. As I understand it,

this (Alexander Paramonov's presence here on earth) is in fact the "second coming," but it is a bit earlier in the process than what most people think of when they think of Christ's return.

Also, remember that Christ warned that his coming will be at a time when people would not expect it. See Matthew 24:38-44; and Luke 12:40. Just because this time may not seem like the time of his coming to you doesn't mean it isn't that time.

3) Apparent obstacle:

The Bible (at Matthew 24:23-27) says that there will be false prophets and false Christs and that if someone claims that Christ has returned one should not believe it:

“²³Then if any man shall say unto you, Lo, here *is* Christ, or there; believe *it* not. ²⁴For there shall arise false Christs, and false prophets, and shall shew great signs and wonders; insomuch that, if *it were* possible, they shall deceive the very elect. ²⁵Behold, I have told you before. ²⁶Wherefore if they shall say unto you, Behold, he is in the desert; go not forth: behold, *he is* in the secret chambers; believe *it* not. ²⁷For as the lightning cometh out of the east, and shineth even unto the west; so shall also the coming of the Son of man be.”

My response:

These passages from the book of Matthew appear to be a strong warning to avoid all claims by others that Christ has arrived. *However*, notice the first word of Matthew 24:23 (in the foregoing quotation): “**Then...**” Christ was speaking of a very specific time.

The two preceding verses from Matthew describe that time period as follows:

²¹For then shall be great tribulation, such as was not since the beginning of the world to this time, no, nor ever shall be. ²²And except those days should be shortened, there should no flesh be saved: but for the elect's sake those days shall be shortened.

So this warning to not listen to anyone who says that Christ is here is a warning for a very specific and extremely unique time. It will be a time of “great tribulation,” which is so horrible that if those days had not been shortened no person would be left alive. We are not living in such a time now (in 2025) and so that warning does not apply yet.

Additionally, note that I am not asking anyone to blindly trust me and take my word for it on this issue. I am asking people to investigate this issue for themselves, and to keep an open mind long enough for them to complete a fair investigation.⁵ After that, they should come to

their own conclusion on the matter, whatever that might be.

In general, to be able to investigate any issue that is before us is a basic human right and an inherent ability that we have as humans. It is not blameworthy to investigate something with an open mind and then to come to one's own conclusion on that issue. There is nothing immoral or wrong about someone doing this.

4) Apparent obstacle:

How can Alexander Paramonov be the Christ when he does not appear to be like the Christ that so many of us imagine? He is not dressed in white robes, performing great miracles,⁶ travelling around on foot, blessing people, and taking all the good Christians up in the sky with him to heaven. And instead he spends considerable time discussing the details of the world financial system, a seemingly mundane topic.

My response:

Christ has no obligation whatsoever to fit into your preconceptions! He is doing work that is appropriate for his role, doing what needs to be done at this time in world history (by taking control of the world's financial system) to break the grip of the parasites (the powers-that-be) on this world, and he is building his bright, excellent new world *right here on earth*. This is consistent with the proper role of the King of Kings (even if he doesn't conform to your preconceptions).

5) Apparent obstacle:

Alexander Paramonov heavily praises the Soviet Union.⁷ But wasn't that nation a totalitarian dictatorship which murdered at least about 40 million of its own citizens? How could any sane person possibly think that the Soviet Union was a great country? If he thinks that then (many might say that) his judgment seems questionable.

My response:

I think that Alexander Paramonov is saying, in essence, that the USSR was under a terrible attack by Satan and his forces during those dark times (when the 40 million plus people were killed; and probably before that as well), and that despite all the awful tactics Satan employed he was unable to destroy "...faith, hope, love, goodness, conscience, honor, justice, selflessness, and mercy in the souls of Soviet people."⁸ The strength of the character of the Soviet people prevailed over and withstood Satan's very harsh tactics. In other words, Alexander's perspective (apparently) is that the fact that the nation of the Soviet Union (and the Russian people) was (were) able to withstand such a horrific, Satanic attack without the Russian people losing their good moral character, amounts to a defeat for Satan and it is a powerful

testament in favor of the Soviet Union (and the Russian people).

6) Apparent obstacle:

Alexander Paramonov refers to Mary Magdalene as Radomir's (a.k.a. Christ's) wife, and to the fact that they had a daughter, Radomir Isii.

My response:

Alexander spoke about Mary Magdalene as Radomir's wife and their daughter Radomir Isii and how some evil men came and murdered these two women.⁹ When (other) men came back and found these murders they made an oath to create the Order of the Templar Knights.¹⁰ And they took some of the blood from these murders and painted a red cross on a white square of cloth, creating the flag of the Order of the Knights Templar.¹¹

For many readers this (the claim that Christ had a wife and daughter) might seem like an outrageous claim, impossible to swallow, and possibly sacrilegious or blasphemous. And for me also this seemed very problematic when I first heard it. It raises a lot of questions if Alexander's story about the life of Christ is so dramatically different from the one presented in the Gospels. However, there are some important facts to consider here which should make these assertions (by Alexander Paramonov) more palatable.

It appears that Alexander was talking about a different prior life of Christ than the one portrayed in the Gospels. Conventional wisdom within contemporary Christianity holds (something to the effect) that each of us has this one life and then when we die we get judged and either go to heaven or hell; and that there is no such thing as reincarnation. But the fact is that the notion of reincarnation is not at all inconsistent with the message of the Gospels and, in fact, some of Christ's statements implicitly affirm the notion of reincarnation.¹²

26And as they led him away, they laid hold upon one Simon, a Cyrenian, coming out of the country, and on him they laid the cross, that he might bear *it* after Jesus.

27And there followed him a great company of people, and of women, which also bewailed and lamented him. **28**But Jesus turning unto them said, Daughters of Jerusalem, weep not for me, but weep for yourselves, and for your children. **29**For, behold, the days are coming, in which they shall say, Blessed *are* the barren, and the wombs that never bare, and the paps which never gave suck.

Why would Christ tell these women to not cry for him but rather to cry for themselves and their children, since (in essence) in the future conditions would be very bad and perverse for women (i.e. “...they shall say, Blessed *are* the barren, and the wombs that never bare, and the paps which never gave suck.”)? Why would he say that to these women? It is evident that he was prophesying about the deplorable, unnatural future conditions for women (which are common nowadays, in 2025) wherein women reject: motherhood, their own inherent mothering nature, their natural and fundamental maternal role in life. But this cultural shift did not begin to occur until about

If people do reincarnate in life after life (as I believe we do), it could be that Christ has repeatedly reincarnated in this world (without identifying himself as Christ in most cases) in order to keep humanity on the right path and to keep Satan in check.¹³

One of the points of this story (that Mary Magdalene was Christ's wife and that they had a daughter) is to explain the origin of the Order of the Knights Templar, and the origin of the flag of that order. Alexander explains that that order was created as a direct result of (and very shortly after) the murders of these two women. But that order was not created until about 1119 CE,¹⁴ which would place that event well after the life of Christ that is portrayed in the Gospels. This fact supports the notion that when Alexander told this story (about Christ having had a wife and daughter) he was talking about a different life of Christ than the one depicted in the Gospels.

So if this analysis is correct then that may make the story, of Christ having had a wife and daughter, more acceptable to some or many readers.

the 1960s, many hundreds of years after the women whom Christ was talking to (and their children) had died. So then why was Christ telling these women to cry for themselves (and their children)? There would be no point in doing so if there was no such thing as reincarnation. The most logical way to understand this is that he told these women to cry for themselves because they (and their children) would, in the future, be reborn into those unnatural and perverse conditions.

Example # 2: In Matthew 24:13 Christ states the following:

“... he that shall endure unto the end, the same shall be saved.”

(In referring to the “end,” Christ is apparently referring to the end of the Great Tribulation, or else the time when Christ returns to restore justice and collect his people into his Kingdom.) But why would Christ say that to his disciples, many hundreds of years before that final end?

And *exactly who* must “...endure to the end” in order to be saved? If we only have one life (and there is no reincarnation) then this advice does not apply to, and was basically irrelevant for, the people he was speaking to when he made this statement, and also it would be not apply to, and be irrelevant for, all of the many subsequent generations that have lived on earth since that time (except the last generation before the end). In other words that statement has been irrelevant to many billions of people, the vast majority of people who have heard or read that statement. Does that make any sense? (No, it doesn't.)

In order to interpret Christ's statement within the paradigm that there is no reincarnation one would have to construe the statement as meaning the following: Christ was telling that very last generation, which would live many hundreds of years later (after he made this statement), that *they* (and he meant *only* they) must make sure and endure to the end (of the Great Tribulation) – which was going to occur within their lifetime – in order to get saved.

But that doesn't make sense. So many people have been reading that phrase in the Bible, generation after generation after generation has been reading it, and yet it doesn't apply to any of those people? (i.e., all those people, all those who are not part of that last generation, do *not* need to bother “endur[ing] unto the end” to be saved?) It only applies to some unknown future generation in whose lifetime the end will come? (Of course, that last generation *could* be us.) Why would Christ speak that way? Why would the Bible be burdened with statements that are not relevant to the vast majority of its readers?

The most natural and straightforward reading of that statement – “... he that shall endure unto the end, the same shall be saved...” – is that Christ was admonishing the very people he was talking to at that time (as well as future generations who would read his statement) by telling them that *they* must stand firm and endure, lifetime after lifetime, until *those same people* (reborn again and again in future lives) come to the very end. That is the reading of that passage which makes the most sense.

And that implies that Christ fully knew about and believed in reincarnation.

Concluding points

As the reader should be able to easily see, my own view is that Alexander Nikolaevich Paraomonov is the Christ, alive in human form on earth today. But I know how incredible and unbelievable that will sound to many people. Thus, I have written this article so as to present this topic in a “pre-digested,” relatively simple and easy-to-understand form in order to help the reader’s mind to grasp and understand this mind boggling topic.

In this article I have, among other things, urged the reader to: (1) keep an open mind; (2) genuinely investigate this matter; and (3) after investigating to come to his own natural conclusion. If the reader does those things it will give the truth of this matter a fighting chance to be properly considered.

I extend my hand to the reader, so to speak, and invite him to step out of the dystopian world that we are mostly living in at this time wherein the forces of evil seem to have the upper hand most everywhere; and to step into a wonderful new world which is being built right under our noses; and in which goodness, justice and truth will prevail.

And if the reader’s mind does open to this new world, he should find a way to help, to contribute towards the creation of it. As Alexander stated in the video titled *2025 – The White King is Coming* (at time stamps 46:00-46:29):

“(46:00) I wish to assure everyone that I will carry this title with honor. And I will make every effort to build a new world in the Cone (Law) of Creation, where human life will truly be the highest value, and human rights will become the basis of the Rule of Law. (46:16) A world where there will be no poverty, wars, inequalities, or discrimination. (46:21) **I expect support and help from all people on Earth who want to make this world a better place for themselves and future generations to live.** (46:29) I declare that the Doors of the King of Kings are open to everyone who adheres to our noble goals, honors universal values, and comes to form synergy for the realization of common bright goals.”
