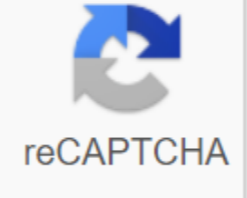

The applicant must have an annual family income below Rs. 75,000/- The following are eligible for the Orphan Scheme of children under the age of 14 as on January 31, 2019Elderly above 60 years, as on January 31, 2019All are in different ways able of any age and widows and disadvantaged women (separated from her husband but have no legal documents) of any age. The applicant should not have used himself/himself in any amount under any other government scheme. Click on to submit the Implementation of the Kasyap Scheme First, a thorough study, short list and final applicants will be made by the State Level Committee (SLC). If the applicant passes the scheme selection criteria, the amounts will be transferred to the SB accounts of the selected applicants. The amount will be transferred within a month. The selection committee at the state level has the power to make exceptions in the selection/selection process in accordance with their convenience and desire, and their decision will be final. Under the scheme, a stipend of 2,000 rubles per month would be awarded to orphans, orphans, widows and the elderly (4,000 rubles per month if any of the elderly living in a nursing home) would be selected as part of the process. The aim of the programme is to help poor children, elderly brahmin, widows, women with disabilities and disadvantaged women financially to cover their food and shelter costs. The applicant must belong to the Brahma community and reside in Andhra Pradesh.
