TO THE ATTENTION OF STATE LEADERS

The letter titled *To the Attention of State Leaders* from Alexander Nikolaevich Paramonov is an open letter to leaders of nations around the world. Alexander Paramonov is the Secretary General and Chief Treasurer of the *Sovereign International Treasury Monetary One* fund (“M1”). (You can read about that fund here: <https://ruskazna.su/en> .)

In that letter Alexander Paramonov offers to finance projects in countries around the world to develop infrastructure and address humanitarian needs. He offers this financing with very generous and helpful terms, as expressed in the following excerpts from the letter:

- M1 can finance “...projects for the creation of large industrial enterprises, enterprises that ensure the functioning of urban and rural infrastructure, social infrastructure facilities and service sector expansion facilities...” (p. 2)
- M1 “...finances 100% of the cost of implementing the agreed projects (without the requirement of co-financing from the State)...” (p. 2)
- “...Simultaneously with the creation of a large number of new jobs with a decent salary and, accordingly, with an increase in tax revenues to the budget of your country, during the implementation of business programs and projects, *the INTERNATIONAL TREASURY MONETARY ONE proposes: to include in project calculations social infrastructure programs of new settlements and cities (housing for employees and their families, kindergartens, schools, hospitals, roads, gas stations, public transport, thermal power stations, water treatment plants, sewage treatment plants, etc.).*” (p. 2) (Italics added.)
- M1 proposes that after an employee has worked with a project and lived in housing provided by the project for 15 years, that home will then be transferred to him for free, so that he will then own it. (p. 3)
- “The employees of enterprises and members of their families will be provided with preferential high-quality private medical care, including abroad, if necessary.” (p. 3)
- M1 offers “[t]o provide, through projects, the necessary industrial training of employees in your country and, if necessary, abroad...” (p. 3)
- **“The INTERNATIONAL TREASURY MONETARY ONE guarantees non-interference in any form in the internal politics of the region, including financial and other support for political parties and movements, religious and public organizations;”** (p. 3) (Bold font in the original.)
- “The amount of funds...” available for any given project “...is NOT LIMITED.” (p. 5)

This seems like an excellent program which could benefit many people and nations.

A comment directed to Americans: I doubt that the U.S. federal government would apply for funding from M1, even if it would be beneficial to do so. But Americans could urge their *state governors and state legislatures* to apply to M1 for funding of projects to be completed within their own states. (Analogous concepts might apply to European and other countries.)
