Haiti Cardiac Alliance works with partners to scale up the availability of
life-saving cardiac surgery to all Haitian children who need it.

Direct surgical matching and travel accompaniment of children and young adults
with heart disease during FY13. Haiti Cardiac Alliance directly facilitated
surgery for 27 patients, including 14 who traveled outside of Haiti for care. We
sponsored foreign visas for these patients and their parents. We arranged and
funded air travel, recruited host families and often directly accompanied families
for surgical care.

Development of patient data management systems. HLA has created a national triaged
waiting list for cardiac surgery endorsed by the Haitian Ministry of Health. This
waiting list system is supported by a comprehensive custom-designed patient
medical records system as well as a platform for the electronic distribution of
echocardiogram studies. These systems are made available to our core medical
partners free of charge.

Screening, diagnosis and follow-up of children and young adults with heart
disease. During FY13, we organized and led three pediatric cardiology clinics in
Haiti during which almost 300 children had the opportunity to be seen by a US
