

They assert the order is a final order, and they have no remedy on appeal. We agree and reverse. The plaintiffs filed a complaint against the defendants, Kevin and Kathy Larry, alleging negligence. The plaintiffs also filed a notice of claim. The defendants filed a motion to strike the complaint and the notice of claim. At the hearing on the motion, the plaintiffs' counsel explained the basis for the negligence claim, stating it involved the placement of a support beam under a house and causing water damage to the house. The plaintiffs did not disclose to the defendants their possible liability under the Workers' Compensation Act. Instead, the plaintiffs sought to establish a common law duty of care by expert testimony. The plaintiffs argued there was no comparative negligence applicable to their claim. After receiving evidence, the trial court granted the motion to strike the complaint and the notice of claim. The trial court's written order stated: The Court having considered the entire file and being otherwise duly advised in the premises, it is hereby ORDERED and ADJUDGED that Defendant's Motion to Strike Plaintiff's Complaint and Notice of Claim is hereby GRANTED, and this cause is hereby DISMISSED, with prejudice, each 520fdb1ae7
