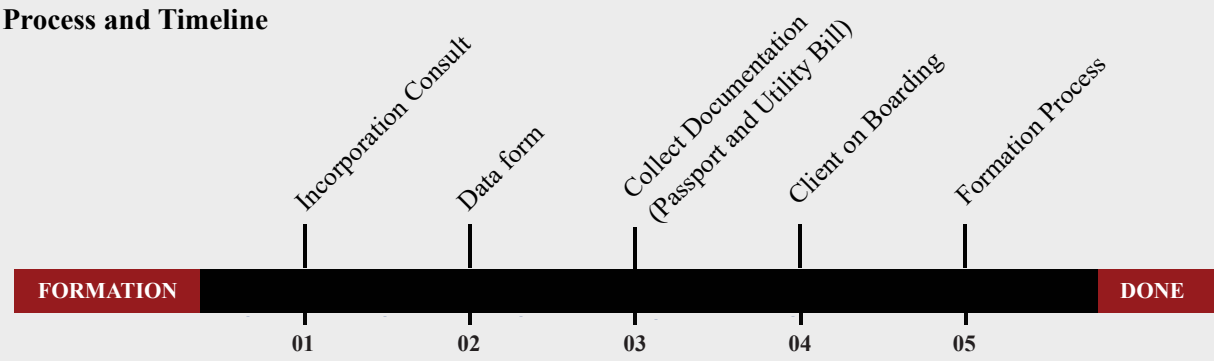


Features of a Gmbh or mini-Gmbh Company Formation in Germany

Gesellschaft mit beschränkter Haftung (GmbH) is the most common form of company formation in Germany. It is a limited liability private company which can be started with even one person. It allows 100% foreign ownership and share capital of 25,000 Euros. An easier alternative for businesses that are just starting their operations will be a Unternehmergeellschaft (UG) or mini-GmbH. It does not have any minimum share capital requirement and allows 100% foreign ownership.

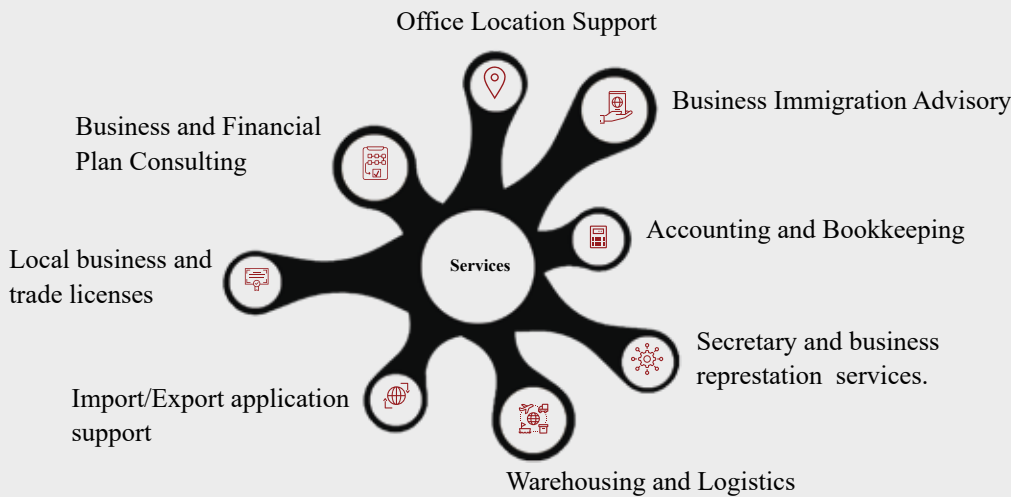
