

Transitions Driving Academy Enrollment Agreement

This Enrollment Agreement (“Agreement”) is entered into by and between Transitions Driving Academy (“School”) and the undersigned student (“Student”) as of the date signed below.

1. Program Enrollment

The Student enrolls in the Transitions Driving Academy Commercial Truck Driver Training Program (“Program”), which includes classroom/online instruction, behind-the-wheel training, and any other services provided as part of the curriculum.

2. Tuition and Payment

Total tuition for the Program is payable in full prior to program start, or per the agreed-upon payment plan.

All tuition and fees are non-refundable, regardless of whether the Student completes the Program, withdraws, is dismissed, fails licensing exams, or for any other reason.

3. No Refund / Withdrawal / Dismissal Policy

The Student explicitly acknowledges and agrees to the following:

- **No Refunds:** All payments are final. The School will not provide partial or full refunds under any circumstances.
- **Voluntary Withdrawal:** If the Student voluntarily withdraws for any reason, tuition and fees will remain fully retained by the School.
- **Dismissal:** The School reserves the right to dismiss any Student for violation of rules, unsafe conduct, or failure to meet academic or training standards. Dismissal does not entitle the Student to a refund.
- **Licensing Outcomes:** The School makes no guarantee that the Student will obtain a commercial driver’s license (CDL) or other certification. Failure to pass tests, examinations, or licensing requirements does not entitle the Student to a refund.

4. Student Responsibilities

The Student agrees to:

- Attend all scheduled classes and driving sessions.
- Follow all School rules, safety procedures, and instructions of instructors.
- Maintain accurate records and provide truthful information in all School forms.
- Comply with state and federal regulations governing commercial driver training.

5. School Rights and Modifications

The School reserves the right to:

- Modify class schedules, instructors, curriculum, and training methods as needed.
- Dismiss Students for non-compliance, misconduct, or unsafe behavior without any refund.
- Make reasonable adjustments to training methods to meet safety or regulatory standards.

6. Limitation of Liability

The Student acknowledges the inherent risks of commercial driving training and agrees that the School is not liable for any injury or personal loss, except as required by law. The Student assumes all risks associated with participation in the Program.

7. Governing Law and Jurisdiction

This Agreement shall be governed by the laws of the state of Texas. Any disputes arising from this Agreement shall be resolved exclusively in the courts of Dallas County, Texas.

8. Entire Agreement

This Agreement represents the complete and exclusive understanding between the School and Student regarding enrollment and tuition. Any prior statements, promises, or agreements not included herein are void.
