MEMBERSHIP

FOR AQHA, APHA, NSBA, CURRENT OWNER AND EXHIBITOR MEMBERSHIPS WILL BE REQUIRED. IT IS THE SOLE RESPONSIBILITY OF THE OWNER/EXHIBITOR TO BE CURRENT MEMBERS. MEMBERSHIP FORMS WILL BE AVAILABLE AT THE SHOW. SHOW MANAGEMENT MUST INSPECT THE MEMBERSHIP CARD OR A PHOTOCOPY OF IT. IF THE EXHIBITOR AND/OR THE OWNER IS A MEMBER BUT CANNOT PRODUCE THE CARD AT THE SHOW, A REPLACEMENT FORM MUST BE COMPLETED AND A NEW MEMBERSHIP PURCHASED AT THE SHOW PRIOR TO ENTERING. THE FEE IS NOT REFUNDABLE.

FOR IRHA, CURRENT OWNER AND EXHIBITOR MEMBERSHIPS WILL BE REQUIRED.

THE CLASSES WILL RUN INTO THE ORDER OF THE CLASSES SCHEDULE. AQHA & NSBA CLASSES WILL RUN CLASS-IN-CLASS, EXCEPT FOR OPEN WESTERN PLEASURE. THE OPEN WESTERN PLEASURE CLASSES ARE JUNIOR AND SENIOR, IF THERE ARE LESS THAN SIX ENTRIES AT TIME OF THE ENTRY DEADLINE, THE CLASSES WILL BE HELD TOGETHER AS AN ALL-AGED CLASS.

LONGELINE & IN HAND TRAIL – ARE EXCLUSIVELY INTENDED FOR 2 YEARS OLD HORSES. HORSES ENTERED IN THESE CLASSES MAY NOT BE SHOWN UNDER SADDLE.

REGISTRATION PROCEDURES:

ENTRIES WILL ONLY BE PROCESSED IF:

- THE ENTRY FORMS ARE FILLED OUT CORRECTLY AND HAVE BEEN SENT BY EMAIL IN TIME FOR THE ENTRY DEADLINE
- FULL PAYMENT MUST BE RECEIVED WITH ENTRY TO RESERVE STALLS.
- FOR ALL HORSES, THE VET PAPERS WILL BE CHECKED LOCALLY BY THE OFFICIAL VETERINARIAN.

BY SENDING THE ENTRY, THE COMPETITOR/EXHIBITOR AGREES TO COMPLY WITH THE RULES AND REGULATIONS AS STATED IN THE SHOW ANNOUNCEMENT, INCLUDING THE DOPING CONCEPT.

EXHIBITORS ARE RESPONSIBLE FOR KNOWING THEIR DIVISION ELIGIBILITY AND THEIR LEVEL STATUS. THEY MUST ACCURATELY COMPLETE ENTRY FORMS AND ASSUMES RESPONSABILITY FOR ANY ERRORS.

THE SHOW MANAGER HAS THE RIGHT TO NOT ACCEPT LATE ENTRIES. PLEASE INFORM GATE PERSONNEL IF YOU PLAN TO SCRATCH A CLASS.

REFUNDS

PRESENTING A VET CERTIFICATE BEFORE THE BEGINNING OF THE SHOW, THE SHOW MANAGEMENT CAN REPAY HALF OF THE STALL FEE AND ENTRY FEE. NO REFUND FOR STALL CANCELLATION AFTER JUNE 1, 2026. ANY WITHDRAWAL OF ENTRIES AFTER THE ENTRY DEADLINE WILL NOT BE ELIGIBLE FOR A REFUND.

NEITHER THE ORGANIZATION OR THE VENUE ACCEPTS ANY LIABILITY FOR LOSS, DAMAGE, OR THEFT OF HORSES AND/OR PROPERTY, NOR FOR INJURY OR DEATH OF HORSES, RIDERS OR VISITORS DURING THE EVENT. SUBMISSION OF A SIGNED ENTRY FORM IS CONSIDERED ACCEPTANCE OF THESE RULES. IF AN ENTRY FORM IS NOT SIGNED, THE FIRST PARTICIPATION IN A CLASS SHALL BE CONSIDERED ACCEPTANCE OF AND AGREEMENT TO THE SAME PROVISIONS.

GENERAL PREVISIONS

THE ORGANIZATION RESERVES THE RIGHT, UNTIL THE ENTRY DEADLINE, TO MAKE CHANGES TO THE EVENT. THE EVENT MAY ALSO BE CANCELLED WITHIN 15 DAYS AFTER THE ENTRY DEADLINE IF THE MINIMUM NUMBER OF HORSES, SET AT 200, IS NOT REACHED AND/OR IF THE CIRCUMSTANCES MAKE THIS NECESSARY. IN CASE OF CANCELLATION BY THE ORGANIZER, ALL ENTRY FEES ALREADY PAID WILL BE FULLY REFUNDED.

INSURANCE, VACCINATION AND OTHER REGULATIONS

EACH HORSE MUST BE LIABILITY INSURED AND DISEASE FREE AND MUST COME FROM A DISEASE FREE STABLE. THE HORSE MUST ALSO BE VACCINATED AGAINST INFLUENZA AND TETANUS. VACCINATION FOR EHV IS OPTIONAL BUT STRONGLY RECOMMENDED BY SHOW MANAGEMENT. THE CERTIFICATE OF VACCINATION MUST ACCOMPANY THE HORSE AND SHOWN AT THE SHOW OFFICE UPON REQUEST. ELEMENTA SHOW RULES ARE TO BE FOLLOWED DURING THE SHOW DAYS.

PARTICIPATION REQUIREMENTS

HORSES RESIDENT IN ITALY MUST BE REGISTERED AS SPORT HORSES WITH A NATIONAL SPORTS FEDERATION RECOGNIZED BY CONI. THE RIDER MUST HOLD A VALID COMPETITIVE SPORTS MEDICAL CERTIFICATE, ISSUED IN ACCORDANCE WITH THE APPLICABLE REGULATIONS. FAILURE TO MEET ANY OF THE ABOVE REQUIREMENTS SHALL RESULT IN EXCLUSION FROM PARTICIPATION.

TRACES CERTIFICATE (TRADE CONTROL AND EXPERT SYSTEM) AND COGGINS ACCORDING TO THE RULES OF OWN COUNTRY OR REGION OF ORIGIN.

DOPING CONTROLS

THE SHOW COMMITTEE SHALL ARBITRARILY CHOOSE CLASSES AND OF THOSE CLASSES, DRAWN BY LOT THE HORSE WILL HAVE TO UNDERGO TO BE TESTED. THE TESTING PROCEDURES WILL ALSO BE DETERMINED BY THE SHOW COMMITTEE. BY SUBMITTING THE ENTRY FORM RIDERS, EXHIBITORS AND HORSE OWNERS AGREE TO THEIR HORSES BEING DRUG TESTED (BLOOD OR URINE). IN CASE OF VIOLATIONS HORSE OWNERS, RIDERS AND HORSES WILL BE DISQUALIFIED FROM THE ENTIRE EVENT. PAID ENTRIES AND STABLE FEES WILL NOT BE REFUNDED. THE HORSE OWNER/PARTICIPANT AGREES TO BEAR THE ENTIRE COSTS OF THE DOPING TEST IN CASE OF A POSITIVE RESULT AND TO GIVE BACK ANY POTENTIAL TITLES, AWARDS AND PRIZE MONEY.

TO BECOME ELEMENTA CHAMPION ALL FOUR SHOWS MUST BE ENTERED. ALL PLACINGS FROM THE FOUR SHOWS WILL BE ADDED TOGETHER TO DETERMINE THE ELEMENTA CHAMPION. IN THE EVENT OF A TIE, THE TIE JUDGE WILL BE DECISIVE.

ALL WINNINGS WILL BE PAID BY BANK TRANSFER WITHIN 30 DAYS OF CONCLUSION OF THE SHOW OR AFTER THE RESULTS OF ALL DRUG TESTS ARE RECEIVED. ALL WINNINGS WILL BE PAID TO THE OWNER AT TIME OF ENTRY OR LEASOR IF LEASED. AMOUNTS PAID OUT: DEDUCTION TAX BASED ON ART. 30 DPR 600/7 (20% FOR THE ITALIAN RIDER AND 30% FOR THE EUROPEAN RIDER).

TROPHY AT ELEMENTA CHAMPION. RIBBONS ARE AVAILABLE FOR EACH CLASS UNTIL 6TH PLACE.
