



# WHAT TO EXPECT AS A CONSIGNER:

## 1. Send us photos of your items

Email clear well-lit photos of your items with non distracting backgrounds to [info@wachterauctions.com](mailto:info@wachterauctions.com) or text them to 240-529-4237 with your name and any details so we can use for advertising if we choose. We reserve the right to decline items for inclusion in the auction or advertising.

## 2. Bring your items to the auction field

We will take consignments on location, the week before and the week of the auction:

**Wed 3/25 - Sat 3/28 10am-5pm**  
**Mon 3/30 - Thurs 4/2 10am-5pm**

We will provide tags and marker for you to mark your items with your Consigner # and will direct you where in the field to place your items. If your item has a title (vehicle, trailer, etc.), please make sure to leave it with your contract in the office trailer, as well as any keys (which will be stored safely off-site until the Auction day).

All consigned items will be staged outdoors in a field before and during the auction. We do not have a place to store items indoors. Please be aware of the outdoor conditions and feel free to take your own protective measures, such as covering your items with a piece of plastic. Please keep in mind that we may need to rearrange or move items to create the most effective display and groupings for the auction.

If you want to consign large items/heavy equipment and need to drop off earlier, please call or text Scott Wachter at 240-529-4237.

## 3. Complete the Auction Consignment Contract

You may clearly hand write the list of items for consignment on our contract or type/print your own list of items with any important details and we will attach to the contract. Leave this in the office trailer at the auction location - make sure it is signed by an Auction Staff.

## 4. After the Auction

After the auction, we will notify you by email about any unsold items. If you do not use email, please let us know so we can send you notification by mail or phonecall. You must pick up any unsold items within 10 days of being notified. A storage fee of \$20 per day will be charged for any items not retrieved after the 10th day from your email notification. Any items remaining on the property for more than 30 days after the auction date will be considered abandoned property and may be disposed of by Wachter Auctions and Appraisals at your expense to be deducted from your payout. You must get your Consigner No-Sale Sheet from the office trailer before removing those items from the property to pass through security.

We will mail your check and a Consigner Settlement Sheet to the name you list on the Consignment Contract and mail to the address listed. Please make sure these are accurate and we have a phone number to reach you.

A storage fee of \$20 per day will be charged for any items not retrieved after the 10th day from their email notification. The CONSIGNER acknowledges that any items remaining on the property for more than 30 days after the auction date will be considered abandoned property and may be disposed of by Wachter Auctions and Appraisals at the CONSIGNER'S expense to be deducted from the CONSIGNER Payout. The CONSIGNER agrees that in the event the auction is canceled for any reason, Wachter Auctions and Appraisals will not be held liable for any monetary damages or losses incurred by the consignor. Consignment Payments shall be made to CONSIGNER 30 business days from the date of the auction by check and mailed to the name and address listed above. Wachter Auctions & Appraisals will retain all commission and buyer's premiums when charged.
