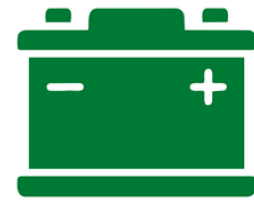

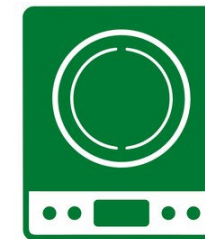

We match applicants with an energy coach to go through the electrification and application process.

Coaches are volunteers who have experience electrifying their home and want to help their neighbors. Some have additional training. A few have professional experience.

Enhanced Home Energy Performance

- Plan weatherization first, then heating/cooling
- Check Enhanced program first, then Standard program
- Eligible: Eversource customers whose household income is at or below the state median



**Enhanced
Home
Energy
Performance**

Benefits

- **Weatherization: 100% off energy audit, air sealing, insulation up to \$15,000**
- **Appliance upgrades: Replace inefficient appliances such as refrigerators, freezers, heating and cooling systems**
- **Additional enhancements: Energy-saving thermostats; possibly, doors and windows**

Enhanced Home Energy Performance

First Step: Visit NHsaves Income Verification Portal

Needed documentation:

- W2, or
- Paystub, or
- Social Security document, or
- Bank statement, or
- Access to bank account





Standard Home Energy Performance

Don't qualify for the Enhanced Home Energy Performance program?

- Standard program offers energy audit and 75% of weatherization costs up to \$6000.
- Eligibility: Have a home that is wasting energy according to NHTSaves standards. No income restriction.
- First step: Click “Test Your Home” at nhsaves.com/residential/weatherization



EVERSOURCE

Demand Response

Two programs that help the utility access affordable electricity in times of high demand by offering **incentives for residents to buy batteries and to sell the stored electricity to the grid.**



EVERSOURCE

NH Clean Energy Fund

Helps residents buy batteries

- Eversource pays \$230/kWh, up to \$3000
- You participate in Demand Response for 3 years
- During “Demand Response Events” from June-September, they will use the electricity from your battery for the grid
- Events are ~3 hours long, always between 3pm and 8pm
- There are usually ~40 events/season



EVERSOURCE

NH Clean Energy Fund

- They won't use your battery in severe weather events
- They won't drain your battery below 20%
- Only Enphase and FranklinWH batteries are eligible
- After 3 years, you can enroll in ConnectedSolutions
- Retroactive to installs after October 1, 2022



EVERSOURCE

Connected Solutions **STARTS MAY 1st**

Pays residents to allow Eversource to use the energy stored in your battery at times of high demand.

Same basic components as the Clean Energy Fund, except:

- **Bring your own battery**
- **Eversource pays you \$225 per kW they use during high demand events from June to September**
- **Average payment is ~\$1000/season**

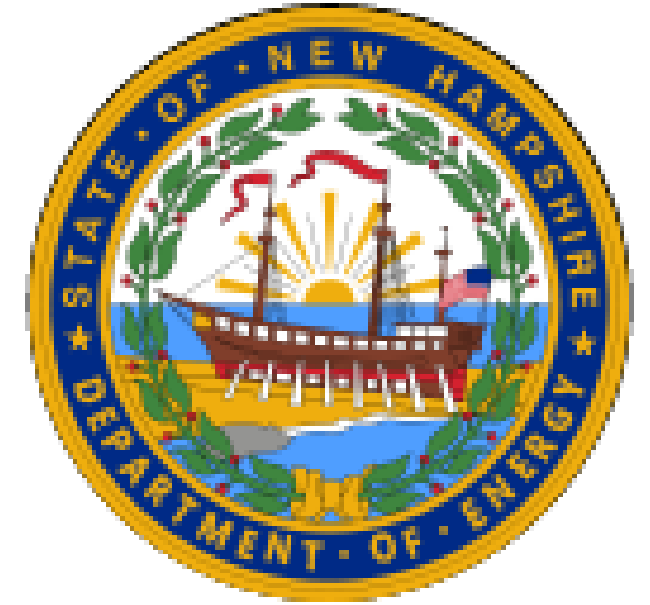


HeatSmart+ rebate program

- Not new, but key features have changed since the program began:
 - No income restrictions
 - Maximum award of \$5000
- Other criteria are unchanged:
 - Resident of Peterborough or Harrisville
 - Living in single-family detached home
- Start at [HeatSmart+ webpage](#)



Home Electrification and Appliance Rebates (HEAR)



- So new that it hasn't started yet (and might never do so)
- Mid-summer 2026 start is predicted
- Sample rebates:
 - Heat pumps \$8000
 - Heat pump water heater \$1750
- Only projects started *after* the program launches are eligible for rebates

New England Heat Pump Accelerator

- Provides discounts to distributors and installers of heat pumps and heat pump water heaters that may be passed on to customers.
- Still being rolled out but some customers have started to see these discounts on their invoices, in the amount of a few hundred dollars



Mix and Match? Sometimes . . .

Not-so-golden rule: One cannot combine rebates from different *federal* sources to pay for the same type of equipment

Federal sources:

- **New England Heat Pump Accelerator**
- **HeatSmart+**
- **HEAR**
