To Squamish Nation Members.

This letter is to provide an update on the recent work completed by the Squamish Nation Electoral Commission.

From November 2015 when the Commission was first created and appointed to present day, the Electoral Commission has worked to "oversee the development of, and amendments to, the Election and Referendum Law" which included "consultation with Squamish members on the development of, and amendments to, the Election and Referendum Law." The goal was to achieve Membership's desire of Election Reform — to amend and update the Squamish Nation's outdated election rules.

The Electoral Commission is comprised of 8 members as follows:

- Dave Jacobs Elder Representative
- Christine Baker Squamish Valley Representative
- · Jacob Lewis Off-Reserve Representative
- Donalene Rapada Off-Reserve Representative
- · Clarissa Antone Seymour & Mission Representative
- · Crystal Brown (nee Paull) Capilano Representative
- · Shayla Jacobs Youth Representative

As well as support from **Brittany John** and **Renee Campbell** as Alternate Members in the event of a resignation, and **Monica Jacobs** as a non-voting member of the Commission and Administrative support. This project was supported by **Dustin Rivers** as a project personnel.

For the past 23 months since first being appointed in Nov 2015, the Electoral Commission has:

- Hosted 42 meetings with Membership. Talking and hearing from approximately 500 members in 2016.
- Held 43 Electoral Commission meetings where Commissioners reviewed notes, comments, and feedback collected at consultation meetings, and used these to write the draft Election & Referendum Law.
- Hosted 16 family dinners in May and June 2017 to present on the draft Election Law
- Conducted a survey in Winter 2016 with **161 respondents**.
- Sent out 6 summary reports on a regular basis.
- Produced a 55-page draft Election & Referendum Law entirely based on input from Members.

The goal of the process for the last two years was to produce a draft document, written by Membership, that would be put to a referendum vote by Membership. This was always intended to be a document for our Membership, by our Members.

We, unfortunately, have to report that the Squamish Nation will not be going to a referendum to address election reform in this Council term.

In May 2017, the Commission held family dinner meetings with three 'open meetings' for any members to attend, as well as family dinners with the Harry, Newman, Lewis, Baker, Jacobs, Williams/Paull/Rivers, Nahanee, Joseph, Williams, Natrall, George, Antone/Cordocedo, Charlie, and Washington state-based families. At these meetings, we used a survey to collect information on how much Squamish Nation members liked or disliked ideas that had been included in the draft law. The Electoral Commission promised the results of this survey would be shared and we've included here to follow up on that promise,

The Electoral Commission members were there to listen to Membership and include Membership's ideas, thoughts, concerns, and feedback. Our objective was always to listen to our Members and write a draft law that would reflect those wishes.

Our hands our up to the many members who took time out of their busy schedule to participate and get involved. You all came to help make our community a better place for ourselves and our future generations, and we want to thank you.






1. How much do you like or dislike the preamble section?




5. How much do you like or dislike the definition of "good standing with the Squamish Nation"?




2. How much do you like or dislike the definition of "conduct that is unbecoming a Councillor"?




6. How much do you like or dislike the definition of "immediate family"?




3. How much do you like or dislike the idea that the chair of Council be elected by Membership?




7. How much do you like or dislike elections happening on the first Sunday in December?




4. How much do you like or dislike having there being dedicated seats on Council for different regions of our nation?




8. How much do you like or dislike requests for referendums require the signatures of 30% of eligible voters?



#### 9. How much do you like or dislike there having "mail-in ballots" for elections or referendums?




13. How much do you like or dislike that to be a candidate in an election, a member must seek the written endorsement of at least 3% of voting population to show community involvement?




14. How much do you like or dislike that if there is a vacancy on Council, that the first and only the first runner-up in the most recent election is given the option to take that position?




15. How much do you like or dislike that if the runner-up declines or is ineligible to take the position, then a by-election is called for members to select the replacement?




16. How much do you like or dislike that by-elections can only happen if there is 15 or more months remaining on the term?




17. How much do you like or dislike that if there is a referendum, any person or group of people campaigning for a particular position in that referendum must register their campaign?






23. How much do you like or dislike that employees or anyone who is elected or nominated are not allowed to use information they obtained from working for the nation to promote a particular candidate?




27. How much do you like that a candidate can file for a recount? (section 4.2.1 a.)
















37. How much do you like or dislike that any amendment to this law must be approved by 60% of the voting members who vote in an amendment referendum?



39. Should the band manager be elected?




39. a. Do you want to see a change in the size of Council (16)? (If you selected no, skip questions 65 (b) and (c).)
