BURN PILE RULES AND ACKNOWLEDGEMENT

(Revised 10/25/25)

Over the past few years, there have been multiple instances of both property owners and others dumping items at the Boat Ramp Area Burn Pile that resulted in situations that put our volunteers and/or their personal equipment in harm's way.

Most property owners want the Burn Pile to remain open; thus, the Burn Committee was established. The Committee was tasked with establishing procedures that would allow the Burn Pile to remain open while simultaneously ensuring the safety of our volunteers and the equipment that they use maintaining the Burn Pile.

Subsequently, to keep the Burn Pile open and to be able to properly address those that choose to ignore the rules of our property owners' association, the Committee created this BURN PILE RULES AND ACKNOWLEDGEMENT letter.

The Committee respectfully requests that you review, sign, and return the attached Acknowledgement Form indicating that you have read and understand the following rules:

- ❖ Ensure that the Burn Pile sign indicates that it is OPEN, otherwise, do not place anything on or near the Burn Pile.
- ❖ The Burn Pile is for burning limbs, leaves, and yard debris ONLY. No other materials are to be placed on or near the Burn Pile (i.e., no construction material, nails, garbage, cardboard, PVC, plastic, cans, metal, etc.).
- ❖ Tree trunks and large limbs are to be cut into 3-4ft. sections. Do not place an entire tree on or near the Burn Pile.
- ❖ Place your yard debris on the Burn Pile, not scattered around it.
- ❖ Only Board Paid Contractors are permitted to use the Burn Pile. Property Owners **CANNOT** authorize any contractors, friends, or others to use the Burn Pile.

Failure to sign and return the Acknowledgement Form will indicate to the Committee that you are forfeiting your privilege to use the Burn Pile.
