# **Privacy Policy**

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use our Service and the choices you have associated with that data.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in order that we can process your booking and provide our Service to you.

### **Definitions**

### Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

# Usage Data

#### Cookies

Cookies are small pieces of data stored on a User's device.

### Data Controller

### User

## Types of Data Collected

## Personal Data

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

- Cookies and usage data

## Cookies and Usage Data

## Use of Data

## **Retention of Data**

Slightly Nomadic Ltd will retain your Personal Data only for as long as is necessary for the purposes of processing your booking. Your data may be held on our CRM software for up to 7 years dependent on how far our adventure goes with you.

Slightly Nomadic Ltd will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time.

## Transfer Of Data

If you are located outside United Kingdom and choose to provide information to us, please note that we transfer the data, including Personal Data, to United Kingdom and process it there.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

Slightly Nomadic will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization
