*All vendors who will be cooking on-site will need to pass a fire inspection. There is a \$25 fee for the fire inspection. **All Vendors are required to have a City of Fountain Inn Business License or a Vendor Day Permit available for \$25 through City Hall.**

Set-Up Time: 7 a.m. – 8:15 a.m. (NO set-ups After 8:30 AM)

Exhibit Hours Open: 9 a.m. – 5 p.m.

Space Information:

- Space area is *approximately* 12 feet by 12 feet *(Specific location not guaranteed)*
- You must provide your own canopies, tents, tables, chairs, and any electrical cords needed.
- NO EARLY TEARDOWN!!!
- \$25 Peddler city permits needed for the day of the festival. \$25 Inspection for Food Vendors.
- *Sponsoring agencies are not responsible for collecting South Carolina sales tax.*

➡ **Vendors must check with SC Dept. of Revenue (864) 241-1200, ext. 128 to verify if a business license is needed for collecting state sales tax**

Fees:

- Arts, Crafts - \$150
- Businesses - \$300 ➡ **MUST Provide proof of Liability insurance, Business License/Permit**
- Political Candidates - \$250
- Food Vendors - \$300 ➡ **MUST Provide proof of Liability insurance, Fire Inspection, and Business License or Day Permit**
- Non-Profit – \$100 fee for display or exhibit – NO items to be sold.
- Non-Profit – *Items for Sale* - \$150 (*Requires approval of Festival Committee*)
- **Chamber Members in Any Category are Half Price!**

Payable in Cash, Money Order, or Check **(Return check fee \$50)**

The Fountain Inn Chamber & Visitors Center reserves the right to reject or prohibit an exhibit, proposed exhibit, or part thereof, including without limitation, any person, articles, conduct, printed materials, catalogs or souvenirs that in its opinion, are not suitable to and in keeping with the character of the Aunt Het Festival.
