

COMPANY REPRESENTATION PACKAGES

PLATINUM PACKAGE - \$10,000.00 advance payment/discounted rate

- Pre-Paid Retainer: Replenish when your firm account is low to ensure continuous representation
- Services are charged at a discounted rate of **\$500.00/hour** (flat fee services also discounted)
- Use on an as-needed basis if your account with the firm contains funds (12-month maximum)
- Excludes client expenses (e.g., filing fees), litigation, and arbitration
- ***Ideal for companies and projects in need of ongoing legal counsel (discounted rates)***

GOLD PACKAGE – \$5,000.00 advance payment/discounted hourly rate

- Pre-Paid Retainer: Replenish when your firm account is low to ensure continuous representation
- Services are charged at a discounted rate of **\$550.00/hour** (flat fees are deducted as stated below)
- Use on an as-needed basis if your account with the firm contains funds (12-month maximum)
- Excludes client expenses (e.g., filing fees), litigation, and arbitration
- ***Ideal for companies and projects in need of periodic legal counsel (discounted hourly rate)***

SILVER PACKAGE – Monthly Retainer (no hourly rate) – \$7,500.00/month*

- We handle ongoing business, contracts, and intellectual property matters
- Minimum two-month engagement (retainer due upon engagement); monthly retainer thereafter
- Ongoing advice and opinions on legal issues that may affect your project or company
- Excludes client expenses (e.g., filing fees), litigation, and arbitration
- ***Ideal for Production Counsel, limited period, or ongoing legal services budget (no hourly rate)***

LLC Formation - \$1,500.00 (includes initial filing fee)

- Search for name availability
- File formation documents
- Secure employer identification number (EIN)
- Draft operating agreement, initial minutes, etc.
- LLC records binder with documents, embosser, and unit certificates
- Legal advice regarding the formation structure

Incorporation (Corporation) - \$3,000.00 (includes filing fee)

- Search for name availability
- File incorporation documents
- Secure employer identification number (EIN)
- Draft bylaws, initial minutes, bank resolution, etc.
- Corporate records binder with documents, embosser, stock certificates, ledger, cap table (if applicable)
- Legal advice regarding the incorporation structure

ASSET PURCHASE AND SALE REPRESENTATION

This service includes handling preliminary matters (NDAs), facilitating due diligence, negotiating definitive agreements, and providing ongoing legal advice. Examples of single transactions include the purchase or acquisition of music catalogs, music royalty streams, motion pictures, business assets, corporate shares, LLC interests, copyright and/or trademark (brand, NIL) rights.

The fee depends on the transaction, but generally includes the following:

- Upfront flat fee for initial work (non-disclosures, letter of intent)
- Success Fee (usually a small percentage) upon completion of a successful transaction.
