For the Geriatric Wellness Subscription, Firestar Veterinary Services, LLC agrees to provide the services listed here:

- Two wellness examinations: one in the spring and one in the fall.
- Vaccination for Eastern Equine Encephalitis (EEE), Western Equine Encephalitis (WEE), Tetanus, West Nile Virus (WNV), Potomac Horse Fever, Equine influenza (flu), Rhinopneumonitis (rhino, EHV), twice per year: once in the spring and once in the fall.
- · Vaccination for Rabies once annually.
- One EIA test (Coggin's test), in the spring.
- One CBC and blood chemistry panel. This evaluates baseline general health.
- Two internal parasite tests via Fecal Egg Count: one in the spring and one in the fall.
- Two deworming treatments for strongyles and tapeworms. (note that additional deworming will be recommended for some horses, and will not be included).
- One baseline ECG, generally done just before sedation. This screens for some cardiac (heart) diseases.
- Sedated dental examination with speculum. (Endoscopic exam will generally be included, but is not guaranteed). Dental float (smoothing of points and equilibration). Dental x-rays, extractions or treatment of dental disease is NOT included.

- One ACTH test, baseline, usually in the fall. The time of year can be adjusted based on your horse's history. This is a screening test for PPID, aka Equine Cushing's disease.
- Tonometry, which screens for glaucoma.
- Year round discounts on professional services and farm visits of at least 5%. (discounts will not apply to prescription medications.)
- Two farm visits, inside the practice area.

## Please note:

- This Concierge Wellness Subscription may not include every preventive health service your horse needs. We may recommend additional services for your horse, at additional cost.
   NOT included are vaccinations for Strep equi (strangles), Lyme's disease (Borreliosis), Leptosporosis or Botulism. These will be recommended for some horses, and are available at additional cost.
- While Firestar Veterinary Service will make every effort to see Concierge Wellness
  Subscription horses for urgent and emergency needs, there will be times when we will be
  unable to do so. We will direct you to another veterinarian on call at those times.
- Horses must be stabled inside the practice area, as shown on our website.
- Horses must be halter trained (halter broke) and generally safe. Firestar Veterinary Services, LLC reserves the right to decline enrollment to any horse that we deem unsafe. Behavior modification charges may apply to some horses with aversive behavior.
- Firestar Veterinary Services Equine Concierge Wellness patients must be housed in a facility that provides a safe working environment for our veterinarians and staff. Firestar Veterinary Services, LLC reserves the right to decline enrollment to horses in situations we deem insufficient to safely and comfortably carry out our work.
- Firestar Veterinary Services reserves the right to exclude patients or clients for poor behavior, non-payment or any other reason. If sedation is needed to accomplish any service safely, it will incur an additional cost (except dentistry, which includes sedation).
- To get an accurate assessment of soundness, your facility must have a safe location with good footing for a moving exam. There is no discount for leaving this exam off of a plan that includes it.
- If all services included are not used, they cannot be refunded, transferred to another horse or rolled over to another year.
- It is the client's responsibility to make the appointments needed to obtain the services on the plan. There will be no refunds except for the specific reasons listed below.
  - · If the horse is sold
  - · If the horse is relocated outside of the practice area
  - · If the horse dies
- In these cases only, Firestar Veterinary Services, LLC will make an accounting of the cost of services you have used, verses the amount you have paid. Then we will issue a refund or give you the bill for your balance. This will be done at our full regular prices, rather than the subscription price. It will take up to 2 weeks to get you this final total. In the event that you

have an outstanding bill with us for any other service on any horse, we will apply any credit balance to that bill.

- This Core Plus Concierge Wellness Subscription is assigned to one horse/owner combination and cannot be transferred to a new owner or new horse.
- The price for the plan includes only the specific services listed here.
