#### 5. Description

A 560ml ready-to-use professional aerosol for use as space/surface fogging, and flush and kill of insects from cracks and crevices.

#### 6. Control

8. Area to use

Cockroaches, Fleas, Spiders, Ticks, Earwigs, Crickets, Sow bugs, Millipedes, Centipedes, Booklouses, Silverfish, Ants, Beetles, Flies, Mosquitoes, Gnats, Wasps and moths, etc.

## 7. Active Ingredient

Deltamethrin (S)-α-cyano-3-phenoxybenzyl (1R, 3R)-3-(2,2-dibromovinyl)-2, 2-dimethyl cyclopropanecarboxylate ...... 0.05%w/v

For general use - Hospitals, supermarkets, hotels, homes, apartments, transportation vehicles (buses, boats, ships, trains), utilities, offices and restaurants, etc.

d-Allethrin (RS)-3-allyl-2-methyl-4-oxocyclopent -2-enyl(1R)-cis, trans-2, 2-dimethyl-3-(2methylprop-1-enyl) cyclopropane carboxylate ...... 0.20%w/v

Dichlorovs 2,2-dichlorovinyl dimethyl phosphate ....... 0.70%w/v

For "crack & crevice" use - food processing plants and other food handling establishments.

## 9. Safety Indication

FNK is a special formulated insecticide prepared for professional PCO use as fogging application for fast control against a broad spectrum of public health pests. When use under the "Good Practice Statement" of NPCA and follow the "Precautionary Statement" of the label, FNK is a safe and highly effective pest control product.

## 10. Application

Flying Insect Control - Flies, Mosquitoes, Gnats, Wasps, Fruit Flies, etc. Close all windows and doors and direct fog upward at a rate of 5 to 6 seconds per 1000 cu ft. Disperse in all directions. Keeps area closed for at least 15 minutes.

Flea & Carpet Beetle - Treat infested area of carpets, fabric objects, localized areas of floors, baseboards, and into cracks and under carpets where these pests may be found. Contact as many insects as possible when treating infested areas. Spray 10 to 30 seconds per 100 sq ft of floor space. Repeat treatment weekly or as insects re-appear.

Crawling Insects - Holds aerosol close to cracks and mist directly into them, contacting as many insects as possible. Apply freely in all possible hiding places behind baseboards, sinks, cabinets, etc. Repeat all treatment as necessary.

## 11. Caution during Application

Avoid skin / eye contact, and inhalation of spray by wearing suitable mask and protecting clothing during application. Do not contaminate water, food or foodstuffs. Remove all pets and birds. Cover fish tanks or remove before fogging. Do not spray directly onto unprotected electrical equipment. Occupants should leave the room or area prior to treatment. Keeps rooms closed and vacated for a minimum of two hours and ventilated adequately before occupants are returned.

## 12. Hazards

#### a) Fire:

Contents under pressure. Do not puncture or incinerate container. Do not use or store near heat or open flame. Exposure to temperature above 130°F (58°C) may cause bursting.

## b) Toxic:

Harmful if swallowed. Toxic to fish and birds.

## 13. Handing and Storage

Store in a good dry place away from heat or open flame.

Keep out of reach of children.

Store away from food, drink and pet feeding stuffs.

#### 14. Disposal

Do not re-use empty container. Wrap container and put in trash collection.

#### 15. General Precautions

Avoid skin / eye contact, and inhalation of spray during application. When using do not eat, drink or smoke. Do not apply directly to surfaces on which food is stored, prepared or eaten. Remove or cover all foodstuffs before application. Protect food preparing equipment and eating utensil from contamination during application. Wash hands and exposed skin before meals and after use.
