

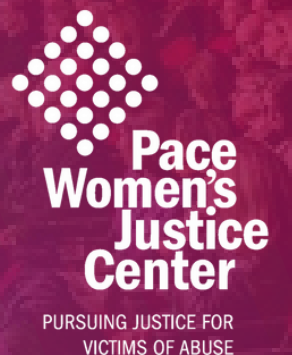

COLBIE CAILLAT & SHAWN COLVIN



Colbie Caillat is a 2X GRAMMY Award-winning, 5X GRAMMY-nominated singer-songwriter whose music has garnered over 15 billion global streams. She has received numerous accolades, including nominations from the Billboard Music Awards, American Music Awards, MTV Video Music Awards, and BMI Pop Awards. Her debut album, COCO, reached #5 on the Billboard Top 200 Albums chart and is certified 3X Platinum, while her Platinum-selling follow-up, Breakthrough, debuted at #1 on the Billboard 200.



Shawn Colvin stopped the industry in its tracks with her arresting 1989 debut, Steady On. The following spring, Colvin took home the GRAMMY Award for Best Contemporary Folk Album, establishing herself as a mainstay in the singer-songwriter genre. In the ensuing 30 years, Colvin has won three GRAMMY Awards, released thirteen superlative albums, written a critically acclaimed memoir, maintained a non-stop national and international touring schedule, appeared on countless television and radio programs, had her songs featured in major motion pictures and created a remarkable canon of work.

PAST BENEFIT CONCERT ARTISTS



INDIGO GIRLS (2023 & 2024 ARTIST)

Grammy-winning duo Indigo Girls headlined the full-length concerts in both 2023 and 2024. With 16 studio albums and over 15 million records sold, Emily Saliers and Amy Ray are one of the most successful folk duos in history. Known for singalong hits like “Galileo,” “Shame on You,” and “Closer to Fine” (featured in the Barbie movie), the pair are also celebrated for their longtime activism and commitment to social causes.



SARAH BAREILLES (2022 ARTIST)

Fresh off her acclaimed Broadway run in Into the Woods Grammy award-w, singer-songwriter Sara Bareilles brought her signature emotional depth and piano-driven sound to the 2022 Raising the Bar Benefit Concert. Her powerful lyrics echo the resilience and strength of PWJC’s clients as they move from crisis to stability. The concert’s name reflects our mission to expand access to free legal services for survivors of domestic violence and sexual assault.

HONOREE

DR. NADINE MACALUSO, PHD.

After enduring marriage to the infamous “Wolf of Wall Street,” Nadine has made it her life’s work to help other women understand, escape, and heal from their trauma bonds with pathological partners. Her own toxic relationship inspired her to become a psychotherapist, specializing in narcissistic abuse, trauma bond relationships, and complex PTSD. And her private practice quickly flooded with women recounting an all-too-familiar story of abuse.

Her book, Run Like Hell, offers the reader both her personal experience and professional expertise to explain the behaviors of pathological lovers (PL), reveal the traits of women who become the “victims” of PLs, how women can leave safely, and most importantly, heal. Nadine shows how women can be “surthrivers” of these trauma bonds and go on to have healthy, positive relationships and lives armed with knowledge and awareness.



AUDIENCE

MISSION SUPPORTERS

Support for PWJC is rising fast. We've seen a 33.6% increase in donation transactions compared to this time last year, fueled in large part by the excitement around Raising the Bar. Our outreach is reaching deeper into Westchester, connecting with more survivors and more people who believe in a future free from violence.
