- The information requested by this form is collected to meet the reporting requirements
 of the Federal Election Campaign Act when a contribution by cash or check is made to
 the Fauquier County Democratic Committee to fund federal election activities.
- This form <u>must</u> accompany any contribution made by cash or check to fund federal election activities.
- If contributing cash please give your contribution and completed form to a Committee
 officer or authorized agent of the Committee as soon as possible but not later than ten
 days after the Date of Contribution on the form.
- 4. If contributing by check please mail your check and completed form to the Fauquier County Democratic Committee, PO Box 213, Warrenton, Virginia, 20188-0213. Your check and form may also be given to a Committee officer or authorized agent of the Committee. The contribution should be in the hands of a Committee officer or authorized agent of the Committee as soon as possible but not later than ten days after the Date of Contribution on the form.
- Incomplete or inaccurate information may delay the use of your contribution or require your contribution to be returned.
