Transcript of the audio in the video titled STATEMENT ON THE GLOBAL CRISIS AND THE RESISTANCE TO OVERCOMING IT

(Edited by Vincent Gillespie; October 2, 2025)

[Alexander Paramonov states the following:]

(0:07) Good day, dear friends. Let me inform ... the nation of Russia, the nation of RSFSR, the nation of the Soviet Union, and also the rest of the world about certain acts that are being done by the extremists of the Russian Federation. I'm going to tell you more about these acts now. You will understand why I refer to them like this from my [report which follows here].

(0:44) I must say that the world is currently in a system crisis that may escalate into [...] the World War III. This is already being talked about among secret cabinets of high-ranking officials, through the lines of secret services of various organizations such as the International Monetary Fund. A few days ago, before Kristalina Georgieva [the Managing Director of the IMF] gave a speech, before her official statement, [through] a diplomat from the International [Treasury] Monetary One, I received a call from the [IMF]. (1:30) The International Treasury Monetary One became the legal successor, and received ownership and possession [...] of all assets of White Spiritual Boy Corporate Global, which are the assets of the entire global financial system, its foundation, all gold accounts, all gold, all global gold, which is also called Sacred Gold or Treasure RA, as the initiated financiers call it. There are many of these accounts. The White Spiritual Boy, the Wonderboy, and many other accounts that make up the whole global financial system and which are used as collateral accounts for currency issuance in each country. In fact this is also the global financial system.

(2:16) We received a message from the owner of these gold assets, the White Spiritual Boy Corporation, which was the owner of these assets from the beginning, the White Spiritual Boy Representative who handed over these assets to us in a direct successor of the King Solomon Lineage. [Note: this representative must be Rizal Salamin.] (2:39) [To] the ordinary people this information may seem strange but believe me to the Vatican and to the other initiated financiers of the world financial centers, such as the World Bank, Commission 300, as well as the other more or less initiated organizations, this information is very understandable and clear.

(3:02) The M1 International Treasury [i.e., the (Sovereign) International Treasury Monetary One] received these assets to lead the world out of the global financial and system crisis, to avert a Third World War, to kick start [the] creative development of humanity, and of course to authorize all these assets in all world financial institutions, control bodies, and all international organizations of the world financial system. (3:34) The World Bank, the International [...] Monetary Fund, [the] Federal Reserve System, the US Treasury, the U.N. International Court of Justice, the BIS Bank, the U.N. General Secretariat, and the U.N General Secretary, the U.N Secret Committees, and the Financial Councils. Of course the Vatican is also among them. The act of transferring all these world assets to M1 was authorized under international law.

(4:09) Prior to the appearance of [...] <u>Kristalina Georgieva, our diplomat, the M1 Global Treasury Diplomat, was telephonically informed by [the] [IMF] Secret Service that M1 needs to get involved in this process due to the catastrophic situation caused by [the] crisis and pandemic. Too many countries in the world have turned to the [IMF] and their resources are just not enough to help all these countries to stabilize their economies, which could lead to a Third World War.</u>

(4:57) Based on this phone call from the [IMF] the International Treasury Monetary One,

which is accredited by the U.N. in the General Secretariat and 26 U.N. commissions, issued the Resolution Number One, based on the rights of the owner of the global financial system, based on the rights of the owner of the Brandenburg Agreement, (5:31) that was based on the assets of the White Spiritual Boy Corporate Global, based on the rights and tasks put before us and with the aim of stabilizing the world and the world economy, with the aim of transitioning to [the] gold standard and with the aim of supporting the [implementation] of Basel III, [the] M1 resolution has been sent to all international organizations working with the financial sphere and regulating it at the international level. The resolution has been sent to leaders of all countries, central banks and so on.

(6:27) It is of course understandable that the forces that want to destroy the world, the extremists and terrorist forces that want to resist peace and who benefit from chaos and destruction, who have committed many crimes and sins, [who] have also committed sins in a financial system which has been recently heavily politicized [...] even though it is forbidden, have begun to illegally manipulate foreign accounts and foreign assets in [...] system banks such as Deutsche Bank and others. (7:09) Of course there are also forces that prevent these criminals from doing evil. Transition to the gold standard puts everything in place, bursts these soap bubbles inflated by the extremists and criminals and returns [to the] people a hard currency secured by the gold that is little affected by inflationary process, thus protecting human labor and human energy invested in the capital that belongs to the people.

(7:52) On the basis of these processes I received several phone calls from offices in the private company [the] Russian Federation. [Those people had been] informed by the [IMF] staff about the situation in our country, the Soviet Union, the RFSFR, and [the] occupying corporation of the Russian Federation which governs the territory of the Soviet Union.

(8:17) The problem is that the resolution [specifies] three reserve currencies which have been enacted [...] by the M1. These are the U.S. dollar until the Nixon period, when it was secured by gold, the Gold Pecu of the Sovereign Order of Hospitallers; I'm also the director of the central bank of the Order of Hospitallers. (8:40) And the Golden Soviet Ruble. Why have these three reserve currencies being chosen? Because they are physically, measurably and stably tied to the Basel III world currency [...] and to the bank gold, the code of which is XAU. On these bases these three currencies are enacted as three reserve currencies for all countries in the world in order to secure the countries' gold balance sheets and thus ensuring the issuance of ... their national currencies.

(9:15) Currencies must be stable against gold because markets have collapsed. The whole system has collapsed. All central bank indicators are artificial. It is not clear what exchange rate they are actually holding against the Euro, against the dollar. And the international markets do not exist. [...] This actually creates a situation where there is no money. There are only some currencies that have ceased to be real currencies and have lost their value. (9:48) The gold standards have been enacted [by Alexander Paramonov] and the whole system has practically moved to the gold standard. So as Kristalina Georgieva said the world's economy has stalled and the artificial intelligence is blocking all international transactions that are built on this fiat basis.

(10:08) In connection with what I have told you let me emphasize that it is necessary under law to move to the gold standard, to these three reserve currencies. The combination of the three currencies is very stable in space and as we know three points form a surface and on [the] basis of these three values it is possible to form securities for all local currencies around the world.

- (10:43) <u>I declare that M1 is ready to help all countries</u>. And that the amount of gold which is in the possession of M1, and in the line of kons ["kon" means natural or divine law], as well as with laws, is sufficient to bring the whole world out of the financial crisis. We are ready to help everyone right down to each individual, every person, every citizen of any country. For us humanity is one whole and we do not build borders in these understandings.
- (11:16) Therefore, we call upon everyone, that is the leaders of countries, all responsible persons, first of all to realize their responsibility in this extraordinary moment [that] the world is in. Now is a turning point and you need to make a decision. You need to understand the responsibility that lies upon you, upon your families and your children because you are the ones holding the responsible posts. And it does not matter who directs you and what strings are being pulled [to control you] because you will be held responsible and also it is you who must make a decision.
- (11:50) Therefore, we announce once again that we are ready to provide gold resources like the XAU currency, denominated in any world currency on the basis of Basel III. We don't even have to ask for permission from any authorities such as from the Fed for dollars or the Hospitaller Council, although I am the Chief Financier of the Council. Because by owning the XAU the law allows us to denominate any world currency. (12:19) We can denominate for all of you treasury bills that cannot be counterfeited due to special production methods and that are secured by gold under all rights and laws, stably secured. We can provide you all with the treasury connection and verification system, with the origin of the issued funds, the history of these gold origins, where it is located and so on. All of this can be provided to those countries and financial institutions which will accept help either through the [IMF] or directly from the M1 treasury.
- (12:58) I repeat that the Brandenburg Agreement is based on our assets, the assets that previously belonged to the White Spiritual Boy [Corporation and which] now belong to the M1. The International Monetary Fund was established under the Brandenburg Agreement, [as was] the BIS Bank, or today's SWIFT System. And since we are practically the owner of the Brandenburg Agreement the [IMF] must of course understand the role of M1, understanding what position the M1 holds in relation to the IMF, and also understand on whose platform this monetary fund works together with the BIS bank and all SWIFT systems.
- (13:42) Our accounts, the M1 accounts, are located in the World Bank, the Vatican Bank, a number of central banks, and all the largest banks in the world. Over a thousand banks hold our open accounts where gold assets are located. We have a large number of accounts, 1,000 accounts, filled with these assets. I also want to tell you that the Rothschilds, Morgans, Rockefellers, Baruchs, the entire Federal Reserve System, have never been the owners of the LIBOR Accounts. (14:17) The LIBOR Accounts always belonged to the White Spiritual Boy Corporative Global and all these financiers [which] you have considered to be the owners only *managed* the platform but never owned it. They do not have the ownership rights to what they declare that they do. To this date M1 is the owner of all this money but that does not mean that M1 usurps all power on earth. It means that M1 clearly and comprehensibly declares that it lives, works and has created this system for the whole nation, for the people, and not for a few usurpers.
- (14:59) The only kon on the basis of which the M1 the M1 system, which is also the world financial system works today is the kon of creation. Everything that will not be in accordance with this kon, believe me, all accounts will be blocked and no IT worker, no worker of any level of access, will be able to do anything with the system because the whole system is controlled by the artificial intelligence. Those who are initiated will understand me.

- (15:30) Today the artificial intelligence fulfills this task and will continue to do so. Various usurpers and war criminals groups can do nothing to the artificial intelligence. You cannot bind it, you cannot imprison it, you cannot do anything [to it].
- (15:46) So here returning to our peacekeeping mission which we have been asked to carry out: the mission of ending the global economic crisis and averting World War III, rebuilding the economies, modernizing the world financial system and leading humanity onto a path of creation. [So this is a peacekeeping mission on a global scale.] It includes all the positive U.N. initiatives and projects [because they correspond to] this vector, and also the anti-poverty programs that have helped us; we will support all the positive and creative initiatives of the U.N. and the leaders and [...] organizers of such programs.
- (16:30) At the same time to this day we have a perfect picture of the situation within the Russian Federation. And I can tell you that the documents intended for Kristalina Georgieva who is both the Executive Director of the Committee of 300 of the World Bank and the Chair of the International Monetary Fund (16:46) have not reached her. They were intercepted by a Hasidic group within the International Monetary Fund, which immediately sent these documents to Russia, to the foreign company of the Russian Federation operating in the territory of our country. The quote "diplomats" of this company, after receiving these documents from the [IMF], were a little shocked and are currently preparing their ignorant answers.
- (17:24) The problem is that the Soviet Gold Ruble is one of the world's reserve currencies. And this is very disturbing for some usurpers who are ignoring and bending the laws and abusing the nation in our country. They are performing genocide in our country. On these bases they have prepared their answers.
- (17:55) Instead of supporting the group that emerged in our bright Russia, our Soviet Union, and created the M1, they would rather spread biased information, to put it mildly, and try to block all these activities. This extremist group does not want peace. They do not want people to receive money or support their situation is only comfortable when the people remain poor. They do not even have enough to pay people this imaginary resurgence support payment that was promised during the Covid pandemic while [they carried] out financial and legal genocide on the nation. So they don't want anything [for the people], and they just, simply have no relationship.
- (18:38) I can confirm this to you from the position of the UN Specialist and Consultant. I have studied this issue very deeply. I have had access to secret documents regarding legal [jurisdiction] and whether [or not] the Russian Federation even has it at all. I can tell you in all concerns that the Russian Federation is a colonizer that occupied Moscow in 1993 when the tanks were firing.
- (19:07) This is also recorded and acknowledged by several African kings at the behest of traitors from the first main directorate of the KGB of the USSR, who installed these kings, trained them, told them in general what the state is, diplomacy, and so on and so forth. At present all regions have entered the colonial model under Moscow because Moscow was the center of control in the Soviet Union. (19:30) And thus it was put in the colonial system, in the colonial dependence upon the company of the Russian Federation, which used to be registered in America through American codes it communicated with the world financial system and in general with the whole system and then it was re-registered in London. And so [the members of this extremist group] colonized the regions, simply made them dependent, spreading their influence there and [employing] their not quite legal acts, so to speak, on the territory of the RSFSR.

(20:00) At the moment, the people who seized our country have written to the

International Monetary Fund, to the same extremists who are part of the IMF, who blocked the flow of information to the head [of the IMF]. They wrote back that, of course, there was nothing to do, no Gold Soviet Ruble, and so on. (20:19) Now I'm officially telling you. The government of the Soviet Union has been restored. Until recently the Soviet Union was registered in the United Nations as a state that still exists, a state that has never been liquidated but which does not have its own government, which dissolved its government. (20:46) This country – in quotation marks – voluntarily divided its territory into specific zones [...] which foreign management companies moved [into]. They assumed the function of presidents according to their own rules, the function of diplomats, function, function, function. That is, they took only functions, but this function does not mean that this is a real diplomat, a real president, and so on. That is why they took control of the service and administration of the territory.

(21:16) Citizens of the Russian Federation in principle do not exist. From the point of view of international law they cannot exist for two main reasons: You can't be a citizen of a company. You can be a product, you can be a debtor, a staff [member], a client, I do not know [...], a partner, but not a citizen of the company. (21:37) Because when [...] a person, unaware of the rules and laws, calls himself or herself a citizen of the company, yes, he [takes] such a name for himself, then, naturally, we can talk about a slight insanity of this person. It is necessary to study the documents and find out what kind of creation this Russian Federation is and whether [or not] it is possible to have a company's citizenship in accordance with international law. Of course not.

(22:10) Secondly, if we don't take the first point into account we will get to corporate instructions, which they call the laws of the Russian federation. It is clearly written there that in order to become a citizen of the Russian Federation one must pass the procedure for obtaining citizenship, a mental capacity assessment. (22:31) Everyone must undergo this procedure. There is no [...] possibility that [a] Soviet citizen automatically becomes a citizen of the Russian Federation, that by the right of birth one automatically becomes a citizen. There is no provision stating that Soviet citizens are automatically transferred to Russian Federation citizenship by birthright. You must *apply* for it.

(22:52) Intelligent people understand that passing this procedure is tantamount to passing a test for [having] a mental disorder; mental irresponsibility confirmed in writing to remain in colonial slavery. Based on this, I want to tell you that citizens, when you go to get a passport, and you received a passport, you always signed a document presented to you (23:18) by someone in a uniform who looks like a policeman from the window, or a migration officer [if] you are a migrant. Either it's the Ministry of Internal Affairs, or the passport office; [they still issued passports.] That is, the questionnaire is like this. And we signed this document without noticing uh written points [referencing] that exact law and a paragraph saying that we sign [acknowledging] our own mental irresponsibility.

(23:46) And [thus] we acquire a guardian in the form of a foreign company that has seized power in our country, the Russian Federation. This company, the Russian Federation, is the largest company in the world. I'm telling you as an international financial expert it is the largest money laundering machine in the world. (24:08) It steals all the funds and capital saved by our grandfathers and ancestors, that is, the Soviet Union. Because Stalin put piles of gold in all sorts of trusts so that communism could be built here, so that the whole world economy would work for the citizens of the Soviet Union, so that sovereign citizens of the Soviet Union would live well and receive income from the trusts and work as they wished. (24:40) These trusts started working, and all this money, all these financial flows from the pension fund, from other

trusts that were assigned, from all sorts of reserve funds, they were stolen by [the] criminals who also created this company, the extremist society of the Russian Federation. These criminals are the seven bankers who manage the financial system, who are still our managers. But this issue is already being resolved. These are the clans, these are not surnames, these are nicknames and clans. The Rothschilds, the Morgans, the Rockefellers, the Baruchs, the Oppenheimers, and so on.

(25:14) It is seven bankers who formed the company called Russian Federation, [and who] [morally corrupted] the top of the communist party of the Soviet Union, the top representatives of the KGB and so on. And they organized a global betrayal, starting with the Washington Agreement, which talks about the transfer of, the sale, the illegal sale, of the Soviet Union. These individuals do not care for legality; they act entirely outside the law. So as a result a non-existent president of the Soviet Union was appointed.

(25:55) Because in the regulations and acts of all the laws of the Soviet Union the position of president is not provided for and any changes to the constitution, the constitutional order, of our great people's country must pass through the Supreme Council, through the Council of People's Deputies and so on. This, of course, did not happen. (26:20) A bunch of Jewish masons who represented the interests of just these, that is, this wild and anti-human capitalism which seized our socialist country and did this betrayal by organizing some kind of state council or something else and introducing such a position as president to which they have already appointed their marked Judas, Mikhail Sergeyevich Gorbachev.

(26:45) This Mikhail Sergeyevich Gorbachev worked very successfully according to the script, together with Yeltsin, and carried out the betrayal. Together they carried out this betrayal and, so to speak, put the people of the Soviet Union and the development of the Soviet Union as a country into a dead end. They organized the betrayal, (27:06) seized power, and, naturally, dissolved the governing bodies, since it is practically impossible to liquidate the Soviet Union under international law and the Constitution of the USSR and, so to speak, all its founding documents.

(27:17) Only **the people** can make [such] a decision. And the people clearly expressed themselves in the referendum in 1991, no matter how they tried to manipulate the results. That is, they used all sorts of dirty political instruments and fraudulent political technologies in a modified form. [Despite all this,] the people voted to preserve the Soviet Union, for the wholeness of the Soviet Union. And this referendum (27:38), this decision of the sovereign people's will, was, so to speak, directly ignored. In other words, this gang that seized our country committed an international crime by establishing their predatory power here, contrary to the referendum.

(28:00) Well, what can be done? Such things have happened throughout history. Sovereignty is an attribute that needs to be fought [for], restored and so on. These processes are happening all the time. Only the methods of warfare were changed at the time. And everything these seven bankers did [...] could not be called anything [other] than international terrorism and international extremism. So these are international crimes.

(28:34) They attacked our country with their criminal and bloody activities, and collapsed its governing authorities. Nevertheless, on the international level, and within the United Nations, the Soviet Union is still considered [to be] a sovereign subject of international law. The company Russian Federation is also an entity, however, an entity that is declared as an invader of the city of Moscow, which territory they have occupied and declared as their own territory. (29:10) Several Africans signed their confessions admitting that it was such. Therefore, there was a need for casualties and shooting in 1993 for the cannons, tanks, and organization of all that

turmoil. Based on these facts, today we can see that everything was a lie.

(29:17) That's why they needed the bloodshed of 1993 — the tanks, the shelling, the manufactured chaos — to create a facade of legitimacy. In reality, however, we were all deceived. The people were shown one image on television — of freedom, reform, and democracy — while the documents submitted to the UN painted a very different picture: **the seizure of Moscow's territory by a corporate occupier.**

(29:28) The nation must know that they showed them one image on television, imagines of freedom, transition to democracy, and so on. But in reality, the documents at the UN are drawn up completely differently. That is to say this is an invader of the territory of Moscow. (29:46) That's why, according to legitimate expert evaluations of actual documentation, this company — the "Russian Federation" — is now classified as an **extremist organization**. This company does not recognize international law at all, which was prescribed by our fathers and grandfathers, who defended peace on earth in the Second World War, who established the equality of nations, the equality of peoples and organized the Security Council and much more.

(30:17) Only after the departure of Joseph Vissarionovich Stalin did the Jewish Fremasonry structures, which are extremist and work against humanity, penetrate once again into the leadership of the Soviet Union, including the Central Executive Committee of the Communist Party of the Soviet Union. U.S. Hasidic structures infiltrated the U.N. and the work of the U.N. began to be influenced by them.

(30:44) I want to explain to people that it is not good to demonize Americans, and there is no need to demonize Europeans, as [it is] being suggested on TV by the same extremist journalists and the same extremist crooks who are spreading and showing us lies instead of truth. (31:00) You just need to understand that there are groups operating in any country. These groups are interconnected. These are secret societies. These are groups whose activities are not based on a moral and bright divine foundation, but their activities are aimed at extremism, terrorism, and destruction. These people are working against humanity. Their goal is to make wars around the world to reduce the population and destroy humanity on earth. That is what they've been doing to this day.

(31:31) However, there is resistance. You may have noticed that Trump eventually raised the flag of light and began conducting special international counter-terrorism operations around the world. He began arresting all those who keep destroying our family, our common kin, our children, arresting human traffickers and so on. He has publicly said that human trafficking is currently gaining momentum never seen before in human history. That is, at this time. We don't live in a "civilized era." We are living in a mad civilization, which is now collapsing.

(32:24) Let me also make it clear to everyone: Democracy is not the power of the people. Democracy is, so to speak, an anti-human system promoted by these financial elites through Roman law [i.e., the legal system of Western Europe up through the early modern period], maritime law, the Federal Reserve, and so on.

(32:40) The word "democracy" is Greek in origin. But in ancient Greek, the term "demos" did **not** mean *the people*. It referred to a **subset** of the population — specifically wealthy urban citizens and feudal lords. The actual Greek word for the masses — the majority — was "**ochlos.**" So if we were to speak of true people's power, the correct term would be "**ochlocracy.**"

Today, if we are to have a meaningful term for popular rule, it should be "people's sovereignty" or, as [it would be] in English, "nationocracy" — power vested in the nation (or something similar).

(33:16) This is why, following World War II, international law established **popular**

sovereignty as the **highest principle** of governance. It declared that nations — that is, their people — must decide their own future: whether to be monarchies, republics, parliaments, or another model. The global consensus was that **power must rest with the people**.

(33:49) And that is the true throne of authority — one now being usurped by international criminals. These are the same criminals Donald Trump and the "white hats" (global anti-corruption forces) are fighting today.

(34:04) What are we seeing now in our country? Every bright initiative that genuinely serves the people — including our own work — is being suppressed. The funds and assets entrusted to us by White Spiritual Boy Corporated Global were not given for selfish or private use. They were passed to serve the people.

(34:20) Just so you understand: not only were the assets handed over to us, but I, Alexander Paramonov, was appointed as:

- The President of White Spiritual Boy Corporated Global, and
- The Chief Officer and Treasurer of the International Treasury M1.

(34:36) So that there would be fewer questions from, so to speak, various critics who resist the light processes on earth. So I can now speak on behalf of both entities, as the President of White Spiritual Boy Corporation Global, which transferred all global assets to the M1 International Treasury, and as the Chief Treasurer of the M1 International Treasury, so that no one has any questions.

(35:00) So once again: we work for the people. We work for the nations. Our mission — our guiding principle, our kon — is creation. Our purpose is the constructive development and prosperity of humanity. It's about love and care for nature, adherence to the laws of the universe, and the promotion and protection of all living things. We are here to preserve life, not to destroy it.

(35:31) Now look at what the so-called "civilized" capitalists have done: They are destroying our shared home — our planet. They are literally annihilating it.

What is communism or socialism, really? The suffix "-ism" is an ancient word rooted in the Earth and people — because humanity once spoke one language. "Ism" means the **truth of the earthly world**. It resonates in us genetically.

(36:13) And what have these perpetrators done? They placed capital — profit — on the throne of that truth.

What did the Soviet Union do? It placed society — the people — at the heart of the earthly truth. That's why socialism means a world where the highest value is the **human being**, the **family**, the **children**, the **elders**, the **ancestral line**.

(36:36) Capitalists, by contrast, are enemies of the family and enemies of humanity. They care nothing for how they make money, or what crimes they commit to gain it. Their entire system is rooted in greed, lawlessness, and rebellion against both **God** and the **natural order**.

(37:06) <u>In conclusion, I want to directly address the extremist organization known as the Russian Federation, as well as those international saboteurs currently interfering with the leadership of the IMF and humanity at large.</u>

Let me make this clear:

(37:25) Your intelligence services are **incompetent**. Your legal teams are **unskilled**. Your sabotage efforts are **doomed**. Everything I have spoken about has **already been authorized** within the global financial system. All the changes have **already occurred**. Your attempts to de-

rail them are not only ridiculous — they will lead to your exposure and downfall. We work in cooperation with international institutions dedicated to combating terrorism, extremism, corruption, and genocide. As the stewards of global finance, it is our duty to carry out this oversight.

(38:27) So before issuing your next batch of ignorant, unlawful statements from behind the closed doors of the Russian Federation's corporate offices, take the time to understand what's really going on — and **who you're dealing with**.

You've already made grave errors, and I advise you not to repeat them. Some countries have now passed classified resolutions supporting M1 in both legal and physical terms — with the authority to conduct counter-extremist and counter-terrorist operations worldwide. So be careful. You may find yourselves in Guantanamo, if they even take you there.

(39:16) You must begin acting within the law, and respecting international norms. Respect humanity. Respect society. And love the people — the very people you currently parasitize. The people are the highest value on Earth, and you have forgotten that.

So I urge you: repent — before it's too late. Wake up. Stop your criminal activity. Your accounts will be blocked — they are already being frozen. Your financial manipulations are coming to an end.

(40:03) Soon, you will see very unusual things happening to your satellites, and other technologies you've weaponized against humanity. These systems will fail. That is the will of the Supreme Mind.

My job is simply to deliver this message — and to warn you that you should think about preserving yourself at least in some kind of existence, at least somewhere. Because what you are doing is now entirely unacceptable — not just by human standards, but by the judgment of Higher Mind.
