	<b>Safety Inspection Areas</b>	Comments/ Action Taken
	<b><u>Inflatable Game(s)</u></b>	
1	Weather conditions are safe for operation of all games	
2	Vinyl/patterns clean and free of stains	
3	Seams and mesh are secure and in good condition	
4	Tie down straps are strong with no breakage	
5	Inflatable is staked in place, and will be anchored at all time	
6	Inflatable is secured by sand bags, and will be anchored at all time	
7	Entrance safety net is secure and in place	
8	Entrance/Exits clear of obstructions and will remain clear	
9	Warning signs are clear and visible	
10	Internal air pressure is sufficient to give a firm footing	
11	No debris or sharp objects are present	
12	Passageways are clear of obstructions	
1	Ropes and footholds are strong and intact	
14	Slide area is controlled by overhanging cover	
15	Inflatable is clear of any utility	
16	If the game is multi pieces connected together, make sure all connections are tight and secured	
	<b><u>Accessories (If Applicable)</u></b>	
1	Blower is clean, and firmly attached to the inflatable	
2	Blower is working and plugged into a GFCI 110V outlet	
3	If using a generator, user all manufacturer's guidelines for operation	
4	Electrical cords are free from wear and do not pose any trip hazards to patrons or guests	
5	Misters are firmly attached and working securely	
6	Water source is clean and free of debris and odor	
7	Exiting water will drain away from the inflatable unit

	<b>Operator / Attendant Responsibilities</b>	Comments/ Action Taken
1	*Supervision by adult trained attendant is required at all time	
2	The Operator/Attendant should point out and make all riders aware of the Rules posted on the game	
3	The inflatable MUST BE securely anchored at all time	
4	Entry into the inflatable device should be orderly and in a controlled manner	
5	Riders should be of similar age range, height, and weight. Do not put older children or adults with younger children	
6	Persons with mental or physical impairment should not be allowed to use any of the inflatable devices.	
7	NO: Riders under the age of 3 years old, or less than 42" tall	
8	NO: Shoes, eyeglasses, jewelry, or other sharp objects	
9	NO: Somersaults, diving, wrestling, rough play, or flips	
10	NO: Food, drinks, gum, pets, or silly string	
11	NO: Smoking, grilling, fireworks, or other heat, flames or flammables near unit	
12	Do not jump onto or off of the ride	
13	Use of whistles and signaling devices	
14	Keep patrons away from the blower at all time	
15	DO NOT USE: Immediately deflate the inflatable if wind conditions exceed 15 MPH and or it rains.	
	<b><u>For Riders with Climbs and Slides:</u></b>	
1	Go down the slide feet first only, one rider per lane at one time	
2	NO: climbing up the slide the wrong way	
3	NO: jumping onto the slide area	
	<b><u>Emergency Procedures:</u></b>	
1	In the unlikely event of a severe Weather Alert, Power Failure, or a Medical Emergency:	
2	Exit patrons in and orderly fashion away from the game	
3	Turn off the blower and unplug from the outlet	
4	Keep patrons and guests away from the inflatable	
5	Call the appropriate emergency responders if necessary

- 1) This rental equipment has been received in good condition and will be returned in the same condition (ordinary wear and accepted)
- 2) Customer agrees to company right to enter premises of customer at any time to repossess said equipment.
- 3) Customer agrees to reimburse Let's BOUNCE for all attorney fees, an amount not less than 50% of all sums due, court cost and expenses incurred by Let's BOUNCE to enforce collection or to preserve or enforce rights under this contract.
- 4) Customer agrees not to loan, sublet or otherwise depose of equipment or use it at any other location.
- 5) Customer agrees to pay in full the replacement cost, including labor, for all damages to rental equipment. **THIS INCLUDES A CLEANING FEE IN THE FULL RENTAL AMOUNT FOR IRON STAINS FROM HARD WATER.**
- 6) If the inflatable equipment is lost, stolen, or damaged beyond repair the renter agrees to pay up to \$3000.00 (Three thousand dollars and 0 cents).
- 7) Customer agrees to ensure that all users (and users' guardians) of the rental go over and read all rules.
- 8) **THERE ARE NO WARRANTIES OF MERCHANTABILITY OR FITNESS EITHER EXPRESSED OR IMPLIED.** The person/s or organization renting this Equipment from Let's BOUNCE will be held responsible and liable for any and all damage or injury occurring for any reason whatsoever. I have read the above agreement and fully understand and accept the conditions as above. I am aware that while in my care I am fully responsible for the inflatable and will pay for any loss or damages that may occur.
- 9) Lessee understands and acknowledges that play on an amusement device entails both known and unknown risks including, but not limited to, physical injury from falling, slipping, crashing or colliding, emotional injury, paralysis, distress, damage or death to any participant. Lessee agrees to indemnify and hold Let's BOUNCE harmless from any and all claims, actions, suits, proceedings, costs, expenses, fees, damages and liabilities, including, but not limited to, reasonable attorney's fees and costs, arising by reason of injury, damage, or death to persons or property, in connection with or resulting from the use of the leased equipment. This includes, but is not limited to, the manufacture, selection, delivery, possession, use, operation, or return of the equipment. Lessee hereby releases and holds harmless Let's BOUNCE from injuries or damages incurred as a result of the use of the leased equipment. Let's BOUNCE cannot, under any circumstances, be held liable for injuries as a result of inappropriate use, God, nature, or other conditions beyond its control or knowledge.
