Hra new britain taxes

@sfrazernbh in the UK - It's not too late for residents to get free, last-minute tax relief before they hand in their income tax this year. The Human Resources Agency of New Britain continues to offer tax assistance at its volunteer Income Tax Assistance facilities in Bristol, Farmington, New Britain and Plymouth. VITA is an IRS-backed program where volunteers train and become IRS certified to provide free tax return preparation for people with low to moderate incomes, according to the HRA. We will generally help people whose incomes are \$54,000 or less to prepare their federal and state tax returns and file them electronically, said Juan Berrios, HRA Community and Financial Services Program Manager. The HRA began operating the VITA program in 2004 with only one place in New Britain. This year, more than 200 volunteers will prepare for tax at 13 locations in Bristol, Farmington, Meriden, New Britain, Plymouth, Southington, Vernon and Wallingford. This includes student IRS certified volunteers who will prepare taxes at Tunxis Community College and New Britain High School. Students from NBHS's Academy of Finance often participate in the program. Volunteers and employees filed 5,629 tax returns in 2017 that returned \$8.9 million of reimbursement dollars to those communities, including \$3.4 million in earned income tax credit refunds. HRA's VITA Program (HRANBVITA): The HRA VITA program is unique in ConnecticutThe North Oak Community Center is the largest VITA area in the state, preparing over 2,000 tax returns annually. It is the VITA Youth Program is the only one of its kind in the state - recruiting and certifying over 30 young adults each year. Human Resources Agency of New Britain, Inc. (HRA) launched New Britain's VITA Program in 2004 as an outgrowth of the New Britain Asset Building Coalition (NBABC). The BBC's goal is to raise awareness and the use of earned income tax (EITC). Under HRA management, VITA has grown every year - since 2004, employees and volunteers have prepared a total of 50,125 federal tax returns. These refunds have returned \$78,961,747 to the larger New Britain community. The VITA program is part of the HRA's Foundations for Financial Independence Program. 2019 was a banner year - VITA volunteers and staff prepared tax returns for 6,633 taxpayers - the most in any year to date. These refunds returned \$10,992,304 to the larger New Britain, Meriden, Wallingford and Bristol communities. VITA income tax assistance also saves low to moderate people money. The average fee for tax preparation is about \$173. In 2019, VITA saved taxpayers \$1,147,509. Our and Funders: HRA does not achieve this alone. She lost her two jobs, her apartment, her car and all her furniture. While in prison, her mother took custody of her two boys, aged 17 and 9. HRA's VITA for Adults Program helped her get back on her feet by preparing her tax returns. Between earned income tax credits (EITC) and other child tax credits, her tax refund was over \$8,000. She paid off her utility debt and was able to put down a deposit and first month's rent on a new apartment. Juanita was also able to buy clothes for her children and the furniture she needed for her new home. HRA's help did not end up preparing its treasures. Juanita's case worker helped her get one of her jobs back within a month of her release. She has a good full-time job and uses public transport. In addition, the case worker helped her get food from the HRA's New Britain Food and Resource Center, as well as SNAP and energy assistance. Juanita's mother lives with her and takes care of her children while she's at work. Her eldest son participated in the HRA's Summer Youth Employment Program, and she plans to participate in the HRA's IDA program so she can save for another car.
