TEAM *contract*

We are thrilled to have your child on our Competitive Tumbling Team! We look forward to a fun and exciting year and are so thankful for the opportunity to coach your child!

This contract is valid from the date of signature through May 31, 2027. Upon signing this contract, you understand that you are expected to pay tuition through May of 2027 and will be responsible for all team fees/tuition regardless of your child's attendance/status on our team.

You and your child's dedication and commitment is very important for their success and progress. Upon accepting your position on Velocity's competition team, I _____(student) & _____(parent) understand and agree that we will participate in 4-5 local competitions and may be expected and encouraged to participate in additional meets that may require travel.

With accepting your position, you are agreeing that tuition includes 2x per week for practice. You may choose to only attend 1x per week but tuition will not be prorated as 2x per week is important for progression. Your child must be in the appropriate team level class unless otherwise approved by Ashley Naylor. Athletes are allowed 2 makeups per month upon approval by Ashley Naylor. Ashley has the right to refuse or revoke makeup lessons at any given time.

As a member of our competition team, you will be training in our gym. Training elsewhere with other coaches will not be permitted and will result in termination of your spot on the team and will be charged the void contract fee. No refund of any fees will be offered.

Please understand that if practice requirements are not adequately met, Coach Ashley Naylor has the right to revoke the student of their participation in the competitions and team practices. No refunds will be given.

Upon signing this contract, I (parent and student) understand and accept the commitment and expectations of Velocity Tumblings Competition Team discussed in its entirety. If, for whatever reason, you wish/must remove your child from the competition team, there will be a \$250 void contract fee plus 1 month tuition if you wish to void this contract (\$385 total). Otherwise, tuition will be due and charged throughout the contracted period.

I understand and acknowledge that all forms of communication will be done via email and it is my (parent) responsibility to check them frequently. If a question is asked that has already been answered in an email, Coach Ashley will refer you to that email.

Please note that any change to a competition roster will result in a change fee of \$20 for our invitationals, and \$25 for regional and megameet, which you will be responsible for. If you are unexpectedly scratching or do not show up at a competition that you are registered for, you will also be charged a change fee at the coaches discretion.

In the event of a mandatory business closure, all classes will be moved to an online platform at a time that Coach Ashley will schedule. The contract will be valid through May of 2026 regardless of in person or online options, unless otherwise stated by Coach Ashley.

By signing the contract, I (parent and student) have read and fully understand the details of this document. I agree to the pricing guide, payment due dates, and understand what is expected of myself and my child. I understand that there are NO REFUNDS OR PRORATES for any team fees or tuition, for any reason including but not limited to, injury(with or without a doctors note), sickness, vacation, missed meets, etc..

I understand that other additional fees may arise and I will be responsible to pay those fees. I understand that a \$10 per week late fee will be applied to my account for any late team fee payments. I understand that Coach Ashley will send me a custom balance based on my gear order and will then send a payment schedule. I understand that I am contractually bound and responsible to pay all team fees and meet all expectations stated by Coach Ashley, both written and verbal regardless of attendance.
