Download Guide for Authors in PDF Part One: Objectives and ScopeThe Environmental Impact Assessment Review (EIA Review) is a reported interdisciplinary journal that serves a global audience of professionals, policymakers, regulators, academics and others with an interest in the field of impact assessment (AI) and management. The impact assessment is defined by the International Association for Impact Assessment (www.iaia.org) as the process of identifying the future consequences of a current or proposed action. For the EIA Review, the field of AI may be related to the assessment of impacts on or on the environment (including, for example, EIA and SEA), social (SIA), health (HIA), risk (RIA), human rights, equity, language, technology, products, etc. With current or proposed actions, the EIA Review public evaluates how best to evaluate the impacts of policies, projects, processes and products and how best to make decisions and carry out management activities. The focus of the EIA Review is on innovative theory and practice that encompasses any of the impacts and activities mentioned above. In other words, the EIA Review covers the following topics (the list is not exhaustive):• Development of AI theory and concepts;• AI legislation, procedure and practice;• Ia Governance;• AI methods, e.g. prediction, indicators, systems-based approaches, ecosystem service assessment, cost-benefit analysis, algorithms, network-based approaches, among others;• Life Cycle Assessment , Carbon Footprint, Energy Analysis, Emerging Analysis and Integrated Product Policy;• Environmental Management Systems.Despite its name, the EIA Review is not restricted to the review of articles. However, it intends to publish only innovative, current and coherent contributions and submissions are judged on these criteria by one of the editors in consultation with an international advisory board. All submissions go through a blind peer review process using a minimum of two reviewers prior to acceptance. EIA Review accepts original research that may adopt a case study project or methodology, but does not accept reports or descriptions only of AI case studies that use existing (i.e. non-innovative) methods in a single jurisdiction context without broader learning points. Thus, case studies are welcome where they explicitly demonstrate innovative theory or practice, and where there is clear value to an international audience. Authors are encouraged to consider recent articles in the journal to get a say on how the editorial team judges potential manuscripts in terms of their innovation, contribution and approach. The journal has three distinct sections (types of publications) and authors must the appropriate section at the point of submission using the drop-down box:• Articles• Current Revisions Point of View All submissions in any of these three sections are expected to present a message of interest to an international audience, in addition to meeting the other criteria described above. Articles are the most common form of submission and should reflect innovative theory and/or practice within the journal. Reviews of current literature are welcome to consolidate the current understanding of art related to some aspect of theory and/or practice, where they identify gaps of interest existing in research for the Community of Internal Affairs, or where they develop new theory. Articles and reviews of current literature should typically be in the range of 5,000 to 8,000 words in length (including tables, figures, and reference lists). Word counts are not strictly enforced, but publishers reserve the right to return articles (for short) that are considered excessively long. The views offer opportunities for professionals to express their informed opinions. They are typically shorter submissions (2,000-4,000 words in length) that are contextually placed, and provide a broader understanding based on experience. As such, they are typically less systematic, more descriptive, but an important way out to communicate wisdom. The evidence may be more anecdotal, but it still needs to be placed in an international context to reflect the breadth of the journal's readers. Submissions to the journal are judged by these criteria by the editor, in consultation with a policy committee, advisory board and other independent experts. All articles undergo a blind peer review prior to acceptance. For the 12 months ended December 2013, the average time between the submission of a paper and an initial decision was 44 days. REVISED SUBMISSIONS Use of word processing software Regardless of the file format of the original submission, in the review you must provide us with a file of the whole article. Keep the text layout as simple as possible. Most formatting codes will be removed and replaced in processing processing Article. The electronic text should be prepared in a very similar way to that of conventional manuscripts (see also the Publication Guide with Elsevier). See also the section on electronic art. Subdivision of article structure - Numbered sections Divide your article into clearly defined and numbered sections. Consecutive number of equations that must be displayed separately from the text (if explicitly referenced in the text). Footnotes Footnotes should be used sparingly. Number them consecutively throughout the article. Many word processors construct footnotes in the text, and this feature can be used.
